Public Hearing

Modifies required coverage of prescription drugs in medical assistance program.

SB

Provides that person may not engage in business as pharmaceutical representative without obtaining license from Director of Department of Consumer and Business Services.

SB764

> Provides that Attorney General and court must presume that resolution agreement that ends dispute over alleged infringement of patent or violation of other protection for protected drug has anticompetitive effects if alleged infringer receives item of value as part of or in connection with resolution agreement or if alleged infringer agrees to limit or stop researching, developing, manufacturing, marketing or selling competing drug.

Includes as unlawful practice medical provider's denial of treatment that is likely to benefit patient based on patient's race, color, national origin, sex, sexual orientation, gender identity, age or disability.

SB355

> CARRIED OVER FROM 03/01/2021 AGENDA: Delays sunset of requirement that health insurance reimburse cost of applied behavior analysis for autism spectrum disorder.

SB358

> CARRIED OVER FROM 03/01/2021 AGENDA: Changes authorization to practice for behavior analysis interventionists from registration to licensure.
