HB 2360 A

Prohibits nonprofit hospital from requiring patient to apply for medical assistance before screening for or providing financial assistance.

HB 2574 A

Clarifies permissibility of disposition of human bodies by alternative authorized processes including alkaline hydrolysis and natural organic reduction.

HB 2261

Prohibits remote sales of inhalant delivery systems.

HB 2508 A

Prescribes requirements for reimbursement by Oregon Health Authority and coordinated care organizations of health services delivered using telemedicine.
