HB 2622 A

Requires hospitals and ambulatory surgical centers to use smoke evacuation system during surgical procedures likely to generate surgical smoke.

HB 3036 A

Allows physician assistant to register with Oregon Medical Board for authority to dispense prescription drugs.

HB 2528 A

Directs Oregon Board of Dentistry to issue dental therapist license to qualified applicant.

HB 2648

CARRIED OVER FROM THE 05/19/2021 AGENDA: Allows pharmacist or pharmacy technician to transfer drug containing pseudoephedrine without prescription to person who is at least 18 years of age and presents person's valid government-issued photo identification.

#### Possible Reconsideration and Work Session

HB 2958 A

Allows pharmacist to prescribe, dispense and administer preexposure prophylactic antiretroviral therapies and post-exposure prophylactic antiretroviral therapies.
