HB 2522 A

Allows Department of Transportation to title park model recreational vehicles based on original manufacturing.

Requires that real estate continuing education courses include information on state and federal fair housing laws.

2761 A

Directs Secretary of State to publish on secretary's website list of top five most commonly spoken languages in Oregon, other than English.

HB 2409 A

Prohibits homeowners associations from requiring application of pesticide on owner's property except as necessary for ecological or public health.

HB 2534 A

Requires homeowners associations and condominium associations to review governing documents and remove discriminatory language or certify the nonexistence of such language on or before December 31, 2022.
