#### **Possible Work Session**

SB 440

Requires Department of Human Services to contract with nonprofit organization to implement and administer program to assist recipients of supplemental nutrition assistance in purchasing locally grown fruits and vegetables from farmers' markets, farm share sites and retail outlets that participate in program.

SB 555

Requires Department of Human Services to contract with nonprofit organization to implement and administer program to assist recipients of supplemental nutrition assistance in purchasing locally grown fruits and vegetables from farmers' markets, farm share sites and retail outlets that participate in program.

SB 717

Provides additional \$10 per month to recipients of Supplemental Nutrition Assistance Program benefits to purchase personal hygiene items.

#### **Public Hearing**

SB 86

Authorizes licensing agency to impose conditions on license to operate residential facility and to consider performance and experience of applicant or licensee in other states or jurisdictions.

SB 88

Corrects statutory cross-references to community developmental disabilities programs.

SB 89

Modifies definition of "developmental disabilities residential facility."

SB 90

Exempts from public disclosure addresses of individuals with intellectual or developmental disabilities residing in adult foster homes, residential training facilities or residential training homes.
