#### **Public Hearing**

SB 279

Directs Department of Human Services, to extent practicable, to avoid scheduling meetings and appointments involving child in foster care during school day.

SB 517

Directs Department of Human Services to provide person having legal custody of child with explanation for child's removal and description of expected remedial steps person must take for child's return.

SB 663

Prohibits Department of Human Services from disclosing records and reports related to child abuse investigations to certain entities unless court finds report of abuse is founded.

#### **Written Testimony**

Written testimony should be submitted via the Oregon Legislative Information System (OLIS) testimony portal. Testimony must be received within 24 hours after the start time of the meeting in which the public hearing is held.
