SB 680

CARRIED OVER FROM THE 3/23/2021 MEETING: Provides funding to peer-run organizations in Portland metropolitan area, southern Oregon region and eastern and central Oregon region to operate peer respite centers to provide peer respite services to individuals with mental illness who experience acute distress, anxiety or emotional pain.

SB 4

Directs Oregon Health Authority to study and make recommendations for improving coordination of youth mental health services among state agencies.

SB 142 **

**Subsequent Referral(s) to Tax Expenditures

Extends sunset for tax credit for child with disability.

SB 144 **

**Subsequent Referral(s) to Tax Expenditures

Extends sunset for additional personal exemption credit for taxpayer with severe disability.

SB 146 ** **Subsequent Referral(s) to Tax Expenditures
Extends sunset for tax credit for working family dependent care.

SB 556
Specifies that on-site inspections must be in person for child-caring agencies, proctor foster homes, private residential boarding schools, foster homes, youth offender foster homes, health care facilities, home health agencies, residential facilities, adult foster homes, developmental disability child foster homes, hospice programs and qualified residential treatment programs.

Work Session

SB 51
CARRIED OVER FROM THE 3/23/2021 MEETING: Removes designation of Department of Education as education provider of certain programs for purposes of provisions related to reports of suspected abuse or suspected sexual conduct.

SB 49
Modifies employment-related child care subsidy program to require certain individuals associated with care provider to be enrolled in Central Background Registry.

SB 50
Requires operators, employees and volunteers of preschool recorded programs and school-age recorded programs to be enrolled in Central Background Registry.

SB 757
Limits availability of conditional enrollment in Central Background Registry to individuals who have successfully completed criminal background check in Oregon and, if applicable, in state of residence.

SB 410
Requires state agencies to develop and implement policies to ensure humane treatment of homeless individuals.

SB 682
Establishes Adult Suicide Intervention and Prevention Coordinator within Oregon Health Authority.

Written testimony must be received within 24 hours of the meeting start time.

Register to testify live remotely:

- Registration is required to testify by phone or video.
