SB 85

CARRIED OVER FROM THE 4/6/21 MEETING: Modifies family-based group home placements to permit respite time for providers.

SB 265

CARRIED OVER FROM THE 4/6/21 MEETING: Requires Department of Human Services to study and make recommendations to interim committees of Legislative Assembly, no later than September 15, 2022, for legislative changes needed to improve care of residents and training of staff in residential programs.

## SB 266

CARRIED OVER FROM THE 4/6/21 MEETING: Requires Department of Human Services to study and make recommendations to interim committees of Legislative Assembly, no later than September 15, 2022, for legislative changes needed to improve care of residents and training of staff in long term care facilities.

#### SB 267

CARRIED OVER FROM THE 4/6/21 MEETING: Requires Department of Human Services to report to interim committees of Legislative Assembly related to human services any changes needed to statutes governing programs administered by department due to changes to budget. 273

#### SB 2

CARRIED OVER FROM THE 4/6/21 MEETING: Directs Department of Human Services to study and make recommendations on provisions of state law related to children.

#### SB 703

CARRIED OVER FROM THE 4/6/21 MEETING: Requires Department of Human Services and Oregon Health Authority to adopt quality metrics for caregiver registries, home health agencies, in-home care agencies and certain residential care facilities.

#### SB 707

CARRIED OVER FROM THE 4/6/21 MEETING: Directs Department of Human Services to provide certain notices to children and wards whom department placed in out-of-state residential facilities between January 1, 2016, and June 30, 2020, and to provide representatives of children and wards with certain documentation and information.

#### SB 710

CARRIED OVER FROM THE 4/6/21 MEETING: Modifies allowed and prohibited uses of restraint of children in care by child-caring agencies, proctor foster homes and developmental disabilities residential facilities.

#### SB 714

CARRIED OVER FROM THE 4/6/21 MEETING: Establishes minimum staffing ratio for residential care facilities and facilities with memory care endorsements.

#### SB 84

Directs Department of Human Services to prepare report regarding Strengthening, Preserving and Reunifying Families programs and make recommendations for legislation.

#### SB 698

Requires Oregon Health Authority to adopt rules requiring opioid treatment center, as condition for approval to operate in this state, to accept Medicare payments as reimbursement for cost of services provided by center.

#### SB 718 \*\*

\*\*Subsequent Referral(s) to Ways and Means Department of Human Services to award grants to

Appropriates moneys from General Fund to Department of Human Services to award grants to refugee resettlement agencies to provide specified services to refugees.

#### SB 686

Establishes right to receive inpatient psychiatric care in person and on-site.

#### SB 721

Modifies charge to and member appointment process for Consumer Advisory Council that assists and advises Director of Oregon Health Authority on mental health and substance use disorder services.

#### SB 680

Provides funding to peer-run organizations in Portland metropolitan area, southern Oregon region and eastern and central Oregon region to operate peer respite centers to provide peer respite
