## **Public Hearing**

HB 2107

Provides that notice of garnishment related to overpayment of public benefits issued by Department of Human Services or Oregon Health Authority need not be signed by person issuing notice on behalf of department or authority.

HB 2108

Removes requirement that independent residence facilities be licensed as child-caring agencies.

HB 3037 A

Directs medical examiner to report suspected suicides involving decedents 24 years of age or younger to local mental health authority.
