HB 3037 A

CARRIED OVER FROM THE 4/27/2021 MEETING: Directs medical examiner to report suspected suicides involving decedents 24 years of age or younger to local mental health authority.

### Public Hearing

HB 2102 A

Requires Department of Human Services to report to interim committees of Legislative Assembly related to human services, by December 31, 2022, comprehensive proposal for department staffing that meets specified criteria.

HB 2106

Renames Children's Advocate to Human Services Ombudsperson.
