HB 2758 A

CARRIED OVER FROM THE 5/20/2021 MEETING: Requires at least two commissioners of Oregon Liquor Control Commission to have public health background.

HB 3139 A

CARRIED OVER FROM THE 5/20/2021 MEETING: Requires mental health care provider who assesses minor to be at imminent and serious threat of attempting suicide to disclose relevant information to parent, guardian or other individuals to engage in safety planning.
