SB 214

(8:25 am) Expands definition of "victim," for purposes of restitution ordered as part of criminal sentence, to include person or entity that has expended moneys on behalf of, or provided services to, minor victim.

SB 217

(8:40 am) Defines "statutory counterpart" for purposes of Oregon Criminal Code and Oregon Vehicle Code.

SB 201

(8:55 am) Provides that person commits offense of driving while under influence of intoxicants if person has blood alcohol level of 0.08 percent or more by weight within two hours after driving vehicle.

SB 218

(9:10 am) Expands types of charges eligible for conditional discharge to include any misdemeanor or Class C felony if defendant has been accepted into specialty court.
