SB 114

Provides for Department of Public Safety Standards and Training to license private security entities that employ private security providers.

SB 115

Clarifies procurement authority of Department of Public Safety Standards and Training.

SB 116

Provides that it is unlawful for private security provider or entity that employs private security providers to possess or use equipment, vehicles, uniforms or titles that imply affiliation with public or private safety agency.
