SB 200

Requires district attorney of each county to adopt written policies concerning guilty except for insanity cases.

SB 205

Authorizes court to commit person to state hospital or secure mental health facility during pendency of petition to commit person as extremely dangerous person with mental illness.

SB 572

Modifies protective proceedings to permit vulnerable youth guardianships for adults between 18 and 21 years of age who are eligible for special immigrant status and who are unable to be

reunified with parent due to abuse, neglect or abandonment that occurred before adult attained 18 years of age.

### **Work Session**

SB 83

Modifies provisions of law relating to youth diversion plan.

SB 131

Adds supervisors of youth correction facilities and juvenile community supervision officers to list of professionals required to make notification of death and cooperate in investigation of death by providing records and other materials.

SB 132

Authorizes Oregon Youth Authority to photograph and fingerprint youth offender if photograph and fingerprint records and files are not provided to youth authority.

SB 211

Directs Department of State Police to maintain staffing level of at least 15 patrol troopers per 100,000 residents of this state, beginning January 1, 2030.

SB 297

Provides that judicial marshal certified by Department of Public Safety Standards and Training qualifies as police officer under Public Employees Retirement System.

SB 436

Modifies terminology by changing statutory references to "youth offender" to "adjudicated youth.".
