# **Public Hearing**

SB 603

(8:05 am - 8:30 am) Directs Oregon Criminal Justice Commission to study establishment of Innocence Commission and system to compensate wrongfully convicted persons, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2021.

SB 620

(8:30 am - 8:55 am) Provides that monthly supervision fee for person under supervision of community corrections program is not automatically required, but may be required by program.

SB 651

(8:55 am - 9:15 am) Provides that probationer or probationer's attorney may file objection to proposed modification to special conditions of probation.

#### **Work Session**

SB 201

Provides that person commits offense of driving while under influence of intoxicants if person has blood alcohol level of 0.08 percent or more by weight within two hours after driving vehicle.

SB 42

Provides that members, officers and certain employees of State Board of Parole and Post-Prison Supervision qualify as police officers under Public Employees Retirement System.

SB 181

Directs court to consider, in determining amount of award of attorney fees, whether attorney performed services on pro bono basis or award of attorney fees otherwise promotes access to justice.

SB 182

Terminates authority of spouse as agent under certain estate planning documents upon annulment, separation or dissolution of marriage.

SB 185

Permits nonprofit corporation organized under laws of other jurisdiction to become nonprofit corporation organized under laws of this state.
