### Work Session

SB 72

Modifies circumstances in which physician or provider may disregard principal's wishes regarding mental health treatment to include when principal is extremely dangerous person committed to Oregon Health Authority.

SB 115

Clarifies procurement authority of Department of Public Safety Standards and Training.

SB 116

Provides that it is unlawful for private security provider or entity that employs private security providers to possess or use equipment, vehicles, uniforms or titles that imply affiliation with public or private safety agency.

SB 180

Requires insurer to notify claimant upon paying \$5,000 or more to settle third-party liability claim if claimant is natural person and if insurer or insurer's agent or other representative,

including insurer's attorney, delivers payment to claimant or to claimant's attorney, agent or other representative by draft, check or other form of payment.

SB 209

Allows owner of interest held in financial institution or holder of traveler's check or money order to demonstrate lack of abandonment by electronic communication or other records by institution or issuer.

SB 565

Modifies definition of "slayer" to include individuals who are found responsible or guilty except for insanity of taking person's life.

SB 566

Removes term "mentally defective" from statutes defining sexual offenses.

SB 768

Modifies provisions relating to attorneys.

SB 829

Clarifies rights of possession of real property following execution sales.

SB 176

CARRIED OVER FROM THE 3/24/21 AGENDA: Creates exceptions to certain privileges in abuse proceedings.

SB 177

CARRIED OVER FROM THE 3/24/21 AGENDA: Establishes exception to prohibition against hearsay evidence, regardless of availability of witness, for certain statements offered against party who engaged in conduct preventing declarant from testifying or causing declarant to refuse to appear or testify.

SB 187

CARRIED OVER FROM THE 3/24/21 AGENDA: Defines "dangerous to self or others" for purpose of taking person with mental illness into custody.

SB 189

CARRIED OVER FROM THE 3/24/21 AGENDA: Requires outpatient care as condition for trial visit of person committed to custody of Oregon Health Authority as person with mental illness.

SB 571

CARRIED OVER FROM THE 3/24/21 AGENDA: Allows persons convicted of felony to register to vote, update voter registration and vote in elections while incarcerated.

SB 578

CARRIED OVER FROM THE 3/24/21 AGENDA: Requires court, under certain circumstances, to appoint legal counsel for respondent or protected person in protective proceeding.

SB 704

CARRIED OVER FROM THE 3/24/21 AGENDA: Provides that discovery of victim's actual or perceived gender, gender identity, gender expression or sexual orientation does not constitute reasonable explanation for extreme emotional disturbance for purposes of affirmative defense to murder in the second degree.

### **Public Hearing**

SB 134

Creates exemption to disclosure of information or records regarding certain youth participating in Oregon Youth Authority programs or treatment.

SB 474

Provides that certain hearsay statements related to certain sex crimes are not inadmissible in evidence even though declarant is available as witness.

SB 649

Increases penalties for criminal sexual contact with underage victim when defendant is victim's teacher.
