#### Public Hearing

SB 274

Modifies certain provisions of law relating to crime of prostitution to exclude child victims of sex trafficking.

SB 497

Requires court to indicate in judgment document when person is convicted of designated person misdemeanor involving domestic violence.

SB 778 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes Office of Immigrant and Refugee Advancement to implement and oversee statewide immigrant and refugee integration strategy.

#### Work Session

SB 752

Provides that defendant's reasonable belief that victim consented constitutes affirmative defense in certain prosecutions for sexual abuse in the second degree and sexual abuse in the third degree.

SB 817 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Eliminates fees, court costs and fines associated with juvenile delinquency matters.

SB 483

Creates rebuttable presumption that person violated prohibition against retaliation or discrimination against employee or prospective employee if person takes certain action against employee or prospective employee within 60 days after employee or prospective employee has engaged in certain protected activities.

SB 209

CARRYOVER FROM THE 3/29/21 AGENDA: Allows owner of interest held in financial institution or holder of traveler's check or money order to demonstrate lack of abandonment by electronic communication or other records by institution or issuer.
