Public Hearing

HB 2036 A

Authorizes State Board of Parole and Post-Prison Supervision to discharge person from parole or post-prison supervision prior to end of supervision term for specified medical reason if compatible with best interests of person and community.

HB 2571 A

Directs Department of Consumer and Business Services, in consultation with State Forestry Department, Oregon Forest and Industries Council, Oregon Small Woodlands Association, Oregon State University, Oregon Prescribed Fire Council and representative of insurance industry, to study liability for prescribed fires.

HB 3041 A

Removes "gender identity" from definition of "sexual orientation" in ORS 174.100 and creates standalone definition of "gender identity" in ORS 174.100.
