SB 95

CARRIED OVER FROM THE 2/2/21 AGENDA; Authorizes Oregon Liquor Control Commission to create data and analysis regarding commercial sales and commercial industries.

SB 588

Provides that employer signatories to multiemployer collective bargaining agreements are considered to have met minimum requirements of sick time provisions if terms of collective bargaining agreement provide, as benefit to employees subject to agreement, sick leave policy or other paid time off program that is substantially equivalent to or more generous than minimum requirements of sick time provisions.

Oregon's Prevailing Wage

Bureau of Labor and Industries University of Oregon Labor Education and Research Center

Public Hearing

SB 493

Provides that prevailing rate of wage for trade or occupation in locality is rate of wage set forth in collective bargaining agreement for trade or occupation in locality or, if more than one collective bargaining agreement covers trade or occupation in locality, average of rate of wage set forth in collective bargaining agreements for trade or occupation in locality.
