Possible Introduction of Committee Measures

SB 406

Allows holder of direct shipment permit to ship up to five cases of wine, each containing not more than nine liters, per month to Oregon resident.

Public Hearing

SB 576

Lowers estimated contract price at which apprentice utilization requirements apply to public improvement contracts with state contracting agencies from \$1 million to \$200,000 and raises percentage of work hours that apprentices must perform from 12 percent to 15 percent.

SB 577

Specifies contract price at which apprentice utilization requirements apply to qualified contracts with institutions of higher education and school districts.

SB 111

Modifies provisions relating to public employee retirement.
