#### **Public Hearing and Possible Work Session**

SB 588

Provides that employer signatories to multiemployer collective bargaining agreements are considered to have met minimum requirements of sick time provisions if terms of collective bargaining agreement provide, as benefit to employees subject to agreement, sick leave policy or other paid time off program that is substantially equivalent to or more generous than minimum requirements of sick time provisions.

SB 495

Defines "instructional capacity" to exclude instructional assistants from scope of statutes prohibiting payment of unemployment insurance benefits to professional employees of educational institution for weeks of unemployment commencing during period between two successive academic years or terms.

#### **Public Hearing**

SB 569

Makes unlawful employment practice for employer to require employee or prospective employee to possess or present valid driver's license as condition of employment or continuation of employment.

SB 317

Allows holder of full on-premises sales license to make retail sales of mixed drinks in sealed containers for off-premises consumption.
