SB 103

Transfers duty to prepare written animal emergency operations plan from Office of Emergency Management to State Department of Agriculture.

SB 109

Directs State Parks and Recreation Commission to adopt rules managing use of unmanned aircraft systems by people in state parks.

SB 130

Delays sunset for pilot program allowing participating irrigation districts to change place of use for water within district boundaries without applying for temporary transfer.
