### Public Hearing

### SB 27

Requires that cover sheet of state, county, district and city initiatives list city and state of residence for chief petitioners, rather than residence address of chief petitioners.

SB 313

In addition to required county delegates, permits state central committee of political party to include as voting member any additional individuals designated by party.

SB 336

Prohibits candidates for state office from accepting contributions in excess of amounts specified and from sources not specified.

SB 343

Permits counties to adopt ranked-choice voting to conduct county elections.

#### **Register to testify live remotely:**
