HB 2560 A

Requires governing body of public body, to extent reasonably possible, to make all meetings accessible remotely through technological means and provide opportunity for members of general public to remotely submit oral and written testimony.

SB 258

Requires Secretary of State to conduct study and analyze provisions of Oregon Constitution, Oregon Revised Statutes and Oregon Administrative Rules relating to voter access.

SB 259

Requires Secretary of State to conduct study and analyze provisions relating to civic engagement.

# AGENDA (cont.) April 29, 2021

#### SB 863

Authorizes rural fire protection district to acquire real property or easement for purpose of establishing fire evacuation route, to construct or maintain fire evacuation route or to participate in agreement related to fire evacuation route.

HB 2681 A

Prohibits moving voter to inactive status due to voter not voting or updating voter registration for any period of time.

HCR 11

Modifies lyrics to state song "Oregon, My Oregon" to reflect cultural, historical, economic and societal evolution of State of Oregon.

Written testimony may be submitted up to 24 hours after the meeting start time.

#### **Register to testify live remotely:**

- Registration is required to testify by phone or video.
  - <u>**Register online:**</u> https://survey.sjc1.qualtrics.com/jfe/form/SV\_8oUiYDwfuFCvH8y You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.
  - <u>**Register by phone:**</u> 833-588-4500 (U.S. toll free). You will be given a phone number to call into the meeting.
- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
