#### **Public Hearing and Possible Work Session**

HB 2001 A

Requires school district that is making reductions in educator staff positions to retain teacher with less seniority if release of teacher would result in lesser proportion of teachers with cultural or linguistic expertise.

HB 3291 A

Requires ballots returned by mail to have postal indicator showing ballot was mailed not later than date of election and be received by county clerk not later than seven days after date of election.

HB 2528 A

Directs Oregon Board of Dentistry to issue dental therapist license to qualified applicant.

SB 4
