Work Session

SB 854

Changes composition of governing board for public universities.

HB 3291 A

Requires ballots returned by mail to have postal indicator showing ballot was mailed not later than date of election and be received by county clerk not later than seven days after date of election.

HB 3398

Delays implementation requirements for paid family and medical leave program.

Public Hearing and Possible Work Session

HB 2026 B

Requires public employers to give preferences to residents of Malheur County for civil service positions if majority of work of position will be performed within Eastern Oregon Border Economic Development Region.

HB 2272 A

Requires Lane County to approve planning application to make permanent certain temporary recreational vehicle parks or campgrounds providing transitional housing for wildfire victims.

HB 2914

Designates April of each year as Arab-American Heritage Month.

HB 3126 A

Directs county board to annex to domestic water supply district, upon petition, land surrounded by district where water supply has become inadequate or contaminated due to wildfire, if district or independent water supply source of district has water supply sufficient to provide water to land.

HCR 28 A

Modifies Legislative Branch Personnel Rule 27 to adopt policies and definitions that conform with recently enacted state law requirements.

Note change: HB 2026 B, HB 2272 A, and HB 2914 have been added.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
