
Alcohol and Drug Policy Commission

Alcohol and Drug Policy Commission (ADPC) is:

- An independent state agency created by the Legislature to improve the effectiveness and efficiency of substance misuse prevention, treatment, and recovery services for all Oregonians.
- Charged with developing a comprehensive Statewide Strategic Plan for Oregon.

Substance Use Disorders and Treatment in Oregon

Nearly 1 in 10 Oregonians aged 12 and older were estimated to have a substance use disorder in 2015-2016 Most Oregonians with a substance use disorder are estimated to not receive treatment

Statewide Strategic Plan

- Reviewed hundreds of pages of documents and conducted listening visits around state
- Focuses on measurable improvements
 - health, social, economic indicators
 - processes for monitoring and reporting progress
- Coordinates state agency efforts
- Establishes a baseline for current state spending and processes for monitoring changes in spending and reinvesting cost savings over time

Goal 1: Coordinated Statewide System

The problem: a deeply siloed system with little coordination

Work in progress: state agencies created statewide vision, mission, and values statement and committed to building a comprehensive and sustainable system

Objectives: increase the degree that state agency leadership is working together, increase system capacity to solve problems and implement needed changes, increase ability to use most effective practices and programs, reduce health disparities and promote health equity
