Dear Rep. Holvey:

You asked the Workers' Compensation Division to provide the committee with information about reported workers' compensation claims related to COVID-19.

We receive some reports of workers' compensation claims, except for accepted nondisabling claims (where only medical services were provided) and City of Portland Fire and Police Disability and Retirement claims (covered by a separate system).

The attached chart shows information about COVID-19 claims reported to the division as of January 25, 2021. Please note the first page of the report lists some important caveats about the data and timing of claim reporting.

The data tables list reported COVID-19 claims sorted by:

- Insurer
- Industry of worker
- Industry grouped by insurer type (SAIF, private, and self-insured employer)

We are happy to answer any questions the committee may have.

Oregon workers' compensation all COVID-19 related claims (through Jan. 25, 2021)

- The data is for accepted disabling, denied disabling, and denied nondisabling workers' compensation claims. The data does <u>not</u> include accepted nondisabling claims. Insurers are not required to report these claims to the Oregon Workers' Compensation Division (WCD). The data also does not have claims filed with the City of Portland's Police and Fire Disability System. **Thus, the spreadsheet does <u>not</u> reflect the total number of workers' compensation claims filed in Oregon and should not be used to calculate overall rates of claim acceptance or denial.**
- In Oregon, a disabling claim occurs when an injury causes the worker temporary disability (time-loss), the worker has or is expected to have permanent disability, or the injury results in the worker's death. Generally, a worker must miss three or more days from work to receive temporary disability. A nondisabling claim occurs when the worker only requires medical services, meaning the worker is not entitled to temporary disability and they do not have a reasonable expectation of permanent impairment.
- Workers' compensation insurers have 60 days to determine whether to accept or deny a claim. Insurers have an additional 14 days after acceptance or denial of a claim to report the claim information to WCD. This results in a lag time in reported data.
- Workers have 60 days to appeal denied claims to the Oregon Workers' Compensation Board. If the denial is overturned on appeal, the claim will be changed to accepted status.
- The data includes claims for both exposure to SARS-Cov-2 as well as those who developed COVID-19 disease. Claim documents do not identify if a worker with COVID-19 tested positive for the virus or was diagnosed based on symptoms or other criteria.
- The data is preliminary and subject to change.

The data set provided includes claims reported with complete information as of Jan. 25, 2021. We excluded from the data 53 potential claims where insurers have not yet reported full details. Once the division receives the remaining information those claims will appear in subsequent data reports.
