Dear Co-Chairs,

Nature of the Emergency/Request

The Oregon Water Resources Department requests retroactive permission to apply for the Federal Fiscal Year 2021 United States Geological Survey (USGS) grant opportunity through the Cooperative Funding Agreements to Support National Groundwater Monitoring Network Data Providers program. Individual applications are restricted to a maximum annual funding level of \$150,000. No specific match rate is required; however, a 50/50 match of agency in-kind services to USGS funding is suggested. The electronic submission application deadline was January 21, 2021 and the Department applied for \$23,981 in federal funding on that date after submitting a 10- day letter back in November.

Agency Action

The Oregon Water Resources Department is a current data provider for the National Groundwater Monitoring Network (NGWMN). The goal of the NGWMN is to provide long-term data needed for planning, management, and development of groundwater supplies to meet current and future water needs and ecosystem requirements. Work to be accomplished under this proposal includes tasks that the Department has always deemed important, but for which it has not had sufficient resources. On January 21, 2021 the Department applied for a request of \$23,981 in federal funds in order to support existing database management and service efforts, purchase water level recording equipment, and potentially rehabilitate observation wells.

Analyst: Matt Stayner

Request: Approve, retroactively, the submission of a federal grant application in the amount of \$23,981 to the United States Geological Survey by the Water Resources Department for funding under the National Groundwater Monitoring Network Data Providers program.

Analysis: The United States Geological Survey (USGS) provides cooperative funding agreements to support long-term data collection activities for the planning, management, and development of groundwater supplies. For federal fiscal year 2021, USGS provided notice to eligible entities that program grant funds of up to \$150,000 would be available to support this work. The Water Resources Department (WRD) provided notice of its intent to apply for the federal grant in November 2020. The application deadline was January 21, 2021.

WRD applied for a grant from the program in the amount of \$23,981 to support their existing database management and services, purchase of additional water level recording equipment, and to potentially rehabilitate certain observation wells. There is no requirement for WRD to provide matching state funds, however, the agency has included existing budgeted expenditures in the application as in-kind match for the federal funds. WRD has sufficient Federal Funds expenditure limitation to expend the funding if awarded.

Legislative Fiscal Office Recommendation: The Legislative Fiscal Office recommends approval of the request.

Water Resource Department Wittekind

Request: Retroactive Authorization to apply for a grant of \$23,981 from the United States Geological Survey through the Cooperative Funding Agreement to support the National Groundwater Monitoring Network program.

Recommendation: Approve the request.

Discussion: The Oregon Department of Water Resources (WRD) requests retroactive authorization to apply for a grant for the National Groundwater Monitoring Network program through the United States Geological Survey (USGS). The goal of the network is to provide long-term data needed for planning, management, and development of groundwater supplies to meet current and future needs and ecosystem requirements.

A 10-day letter was submitted in November 2020. On January 21, 2021, WRD applied for a grant of \$23,981 in Federal Funds. If awarded, the funds would support existing database management and service efforts, purchase water level recording equipment, and potentially rehabilitate observation wells.

Matching funds are not required by USGS, but an in-kind match is encouraged. WRD plans to match any Federal Funds received though agency in-kind services. No expenditure limitation is needed.
