






### **2021-23 Governor's Budget** DOJ Expenditures \$710.3 million







## **AG Office Updates**

- In January 2020, the Civil Rights Unit launched the Hate Crimes and Bias Incidents Response Hotine (BRH) pursuant to SB 577 Section 8.
- As of December 2020, the hotline received 1,069 statewide reports of bias & hate that overwhelmingly targeted victims who identify as Black and/or African American. Also reports of bias against Asian and Pacific Islanders during the pandemic. There was a massive spike in hate crimes in June.
- Submitted as an appendix item to our budget presentation is a 2020 DOJ Annual Report listing the highlights of our services, accomplishments and outcomes related to consumer protection, the protection and support for Oregon children, services to victims of crime, protecting the state in legal actions, providing legal services and advice to our client agencies and supporting law enforcement agencies across the state.

# **Consumer Protection Price Gouging**

- Conditions for Price Gouging:
  - Abnormal disruption of the market declaration by Governor
  - Sales at an "unconscionably excessive price"
- Applies to "essential consumer goods or services"
  - Items necessary for health, safety, welfare (food, water shelter)

# **Protection and Education Account – Other Work**

- Antitrust
  - Price discrimination, price fixing, monopolies
- False Claims
  - Recovery of funds paid by state agency based false or fraudulent information
- Foreclosure Avoidance Program
  - Mediation program to assist homeowners with face-toface meeting with lender
  - Goal: information sharing and avoidance of foreclosure where possible


- Plaintiff lawyers for the State
  - Recover money/property owed to state agencies
    - Fire Suppression Costs
    - Overpayment of Benefits
    - Highway Damage
    - Breach of Contract
  - Protect state's interest in bankruptcy/lien foreclosure
  - Handles cases in which state agency seeking relief
    - Civil Commitments
    - Conservatorships/Guardianships
    - Injunctive Relief
  - Workload Factors: Number/Complexity of Cases

# **Civil Recovery – Child Support**

- Assist Oregon families and children by representing Division of Child Support
  - Establish, modify and enforce child support orders; establish paternity; pursue contempt actions when obligor does not pay required support
  - Training and education:
    - Child Support Bench Book
    - Training to DCS staff, private attorneys, DDAs and OJD
- Recoveries
  - Payments to Oregon families increases after contempt actions are filed
  - Holistic approach emphasis on payments and job search
  - Responded to pandemic and wildfires with increased flexibility
- Workload Factors: Number of cases, economy



# **Civil Recovery – Wildfire**

- Wildfire suppression cost recovery
  - Assist Oregon Department of Forestry
  - Investigate Cause and Origin
  - Recovery from responsible party (if one exists)
- State and Private protected forestland
  - Exceptions include:
    - Federal/County Land
    - Unless Agreement
  - Thus, not all fires
- Complicated Investigations


# **Civil Recovery - Tobacco**

- Protect Tobacco MSA Income Stream
  - \$140-\$160 million to State Treasury each biennium
  - More than <u>\$1.7 Billion</u> to date
  - Payment obligation into perpetuity
  - Prior Litigation: Settled through 2022
- Regulation of Cigarette Sales in Oregon
  - Obligation to enforce "NPM Escrow Statutes"
  - Maintain directory of products approved for sale
- Workload factors: Volume of companies/sales, litigation with MSA participants

# **Medicaid Fraud**

- Federally-mandated program to address:
  - Fraudulent practices in Medicaid Program/Oregon Health Plan
  - Physical or financial abuse and neglect of:
    - Persons by Medicaid/OHP providers
    - Residents of long-term care facilities or non-residential Medicaid recipients
- Provide training and education
- Funding:
  - 75% federal match
  - 25% penalties and settlements
- Workload Factors:
  - Federal expansion of role, increased enrollment in Oregon Health Plan (Medicaid)



# **Child Advocacy**

- Section attorneys represent the Department of Human Services Child Welfare Program (DHS):
  - Provide litigation support and legal advice in all Juvenile Dependency and Termination of Parental Rights cases
  - Appear at administrative hearings regarding foster care certification cases and prepare agency final orders
  - •Responsible for general legal advice specific to issues impacting child welfare and child safety
- Workload factors: COVID pandemic, complexity/lengthy history of cases, unpredictable volume of cases, lack of system efficiencies, other statewide emergencies (wildfires, housing)

## **Emergency Legal Advice**


New: Consultation with DHS pre-filing of Dependency Petitions

In 2020, ChAS AAGs provided 4,174.4 hours of emergency legal advice to Child Welfare caseworkers in every county to determine whether DHS has legal sufficiency to remove a child and to prevent unnecessary trauma of removal.

## **Court Hearings and Trials**



 Section AAGs prepared for and appeared on behalf of DHS caseworkers at a significant number of court hearings statewide, including complex multi-day trials.

 Associated AAG & staff workload includes witness and exhibit preparation, subpoenas, legal service, filing pleadings, drafting judgments, reviewing voluminous discovery, and settlement discussions, et al.





### **DHS Child Welfare Case Worker Satisfaction**

- 68% of Child Welfare case workers report legal issues in their cases are being appropriately addressed in a timely manner compared to their experiences prior to DOJ Full Representation.
- 65% of Child Welfare case workers report their overall experience of the court process has been more positive compared to their experiences prior to DOJ Full Representation.

 Retention of Child Welfare case workers has increased over time since DOJ Full Representation began.



# Whom do we serve?

**Oregon's program provides services for all families** 

- who are currently or were formerly receiving Temporary Assistance for Needy Families (TANF) or Medicaid
- who have never received public assistance and apply directly for child support services
- when a child is in the care and custody of the state, either the Child Welfare system or the Oregon Youth Authority






# **Program Caseload**


Investing state funds in the Oregon Child Support Program yields a high return on investment.

- Every \$1 of state general funds spent on child support is matched by \$2 of federal funds
- In FFY 2020, the Oregon Child Support Program collected \$373 million, including \$348 million for families, reducing the need for public assistance, helping lift families out of poverty, and avoiding additional costs for taxpayers
- In FFY 2020, the Oregon Child Support Program recovered
   \$25 million for state agencies

#### **Cascading Effect**



#### Total Applications 2006 - 2020



- *Ramos v. Louisiana* (2020): Sixth Amendment requires unanimous jury

- Follow-up litigation over unanimous verdicts, retroactivity, other issues






