#### WHAT THE MEASURE DOES:

Renames Office of Emergency Management to Oregon Department of Emergency Management (ODEM) and establishes Department as independent state agency. Transfers all unexpended balances for Office of Emergency Management within Oregon Military Department to Oregon Department of Emergency Management. Transfers Oregon Emergency Response System from Department of State Police to Oregon Department of Emergency Management. Confers to Oregon Department of Emergency Management certain emergency authorities regarding public health emergencies, emergency quarantines and conflagrations. Transfers rulemaking authority regarding nuclear emergencies from State Department of Energy to Oregon Department of Emergency Management. Directs ODEM to carry out certain functions related to regional and statewide emergency preparedness. Renames Office of State Fire Marshal to Department of State Fire Marshal (DSFM) and establishes Department as independent state agency. Transfers all unexpended balances for Office of State Fire Marshal within Department of State Police to Department of State Fire Marshal. Transfers search and rescue duties, functions, and powers from Oregon Department of Emergency Management to Department of State Fire Marshal. Transfers all unexpended balances for search and rescue functions within Oregon Department of Emergency Management to Department of State Fire Marshal. Requires State Fire Marshal to establish wildfire buffer zone guidelines to provide defensible space for lands in forestland-urban interfaces. Renames Oregon Homeland Security Council to Oregon Homeland Security Commission and transfers Commission to Office of the Governor. Modifies duties of Commission and adds members to Commission. Transfers all unexpended balances for Oregon Homeland Security Council within Oregon Department of Emergency Management to Office of the Governor for Oregon Homeland Security Commission. Establishes Emergency Preparedness Advisory Council to advise and make policy recommendations to Oregon Homeland Security Commission regarding federal emergency support functions. Established Local Government Emergency Management Advisory Council to provide advice and recommendations to Oregon Department of Emergency Management regarding department's emergency preparedness and response functions. Becomes operative on July 1, 2023.

#### **EFFECT OF AMENDMENT:**

- -1 Replaces the measure. Renames Office of Emergency Management to Oregon Department of Emergency Management (ODEM) and establishes Department as independent state agency. Transfers all unexpended balances for Office of Emergency Management within Oregon Military Department to Oregon Department of Emergency Management. Transfers Oregon Emergency Response System from Department of State Police to Oregon Department of Emergency Management. Confers to Oregon Department of Emergency Management certain emergency authorities regarding public health emergencies, emergency quarantines and conflagrations. Directs ODEM to carry out certain functions related to regional and statewide emergency preparedness. Renames Office of State Fire Marshal to Department of State Fire Marshal (DSFM) and establishes Department as independent state agency. Transfers all unexpended balances for Office of State Fire Marshal within Department of State Police to Department of State Fire Marshal. Requires State Fire Marshal to establish wildfire buffer zone guidelines to provide defensible space for lands in forestland-urban interfaces. Renames Oregon Homeland Security Council to Oregon Homeland Security Commission and transfers Commission to Office of the Governor. Modifies duties of Commission and adds members to Commission. Transfers all unexpended balances for Oregon Homeland Security Council within Oregon Department of Emergency Management to Office of the Governor for Oregon Homeland Security Commission. Establishes Emergency Preparedness Advisory Council to advise and make policy recommendations to Oregon Homeland Security Commission regarding federal emergency support functions. Established Local Government Emergency Management Advisory Council to provide advice and recommendations to Oregon Department of Emergency Management regarding department's emergency preparedness and response functions. Becomes operative on July 1, 2023.
- -2 Removes requirement that State Fire Marshal establish guidelines for wildfire buffer zones that provide defensible space on lands in forestland-urban interface.
- -4 Removes Section 25 regarding transfer of quarantine authority from the Director of Department of Agriculture to the Director of Department of Emergency Management; restores original statutory language.
- -6 Removes Section 17 regarding public heath emergencies; restores original statutory language. Removes Section 23 regarding authority of Director of Oregon Department of Emergency Management; restores original statutory language.
- -7 Restores name of Oregon Homeland Security Council. Adds mission of the council. Modifies duties of council. Adds additional members to council. Removes Sections 149-150c regarding actions, proceedings, prosecutions, liability, duty, obligation, and name change of council; restores original statutory language. Add mission of Emergency Preparedness Advisory Council. Adds additional members to council. Allows Governor to appoint additional members as necessary. Modifies duties of council. Establishes Local Government Emergency

Management Advisory Council with the Oregon Department of Emergency Management. Adds additional member to council.

- -8 Establishes Fire Marshal Task Force and requires task force to make recommendations to Legislative Assembly on whether office of State Fire Marshal (office) should be made an independent state agency or which state agency office should be housed in, by February 1, 2022. Requires task force to consist 14 members; two members from Senate, two members from House of Representatives, Governor's Public Safety Policy Advisor, State Resilience Officer, State Fire Marshal, one member to represent State Forestry Department, one member to represent fire chiefs in Oregon, one member to represent special districts, one member to represent firefighters employed by or under contract with a state agency, and four members from public at large. Requires office to become independent state agency by January 1, 2024.
- -11 Remove Section 18 regarding public heath emergencies; restores original statutory language. Establishes Implementation Task Force and requires task force to make recommendations to Legislative Assembly on whether Office of State Fire Marshal (office) should be made an independent state agency or which state agency office should be housed in, by February 1, 2022. Requires task force to consist of Fire Service Policy Council. Requires office to become independent state agency by July 1, 2023. Changes Section 155 operative date to July 1, 2022. Changes Section 16a operative date to July 1, 2025. Adds Emergency Clause.
- -12 Restores name of Oregon Homeland Security Council. Adds mission of the council. Modifies duties of council. Allows Council to meet as needed to carry out the mission of the council, at times and places specified by the call of the chairperson or of a majority of the members of the council. Adds additional members to council. Removes Sections 149-150c regarding actions, proceedings, prosecutions, liability, duty, obligation, and name change of council; restores original statutory language. Adds mission of Emergency Preparedness Advisory Council. Adds additional members representing private sector, nonprofit community with a designated emergency support function responsibility, and tribal interests to council. Allows Governor to appoint additional members as necessary. Modifies duties of council. Requires Emergency Preparedness Advisory Council to sunset on January 2, 2030. Establishes Local Government Emergency Management Advisory Council with the Oregon Department of Emergency Management. Adds additional member to represent 9-1-1 emergency dispatchers to council. Requires Local Government Emergency Management Advisory Council to sunset on January 2, 2030.

## **BACKGROUND:**

The Office of Emergency Management (OEM) is located within the Oregon Military Department and manages a statewide system that coordinates emergency services and disaster communications. OEM also coordinates Oregon's 9-1-1 program, awards grants for emergency response equipment to local governments, and oversees search and rescue efforts by lead by county sheriffs. The Director of OEM is the liaison between the Governor's Disaster Cabinet and the State's Emergency Coordination Center which serves as a central communications hub when there is a multijurisdictional response to an emergency.

The Office of the State Fire Marshal (OSFM) is located within the Office of the State Police. OSFM was established in 1917 and its current mission is to protect Oregonians and their property, as well as the environment from both hazardous materials and fires.

The Oregon Homeland Security Council is part of the Office of Emergency Management. The council consists of two members from the Senate appointed by the President of the Senate, two members from the House of Representatives appointed by the Speaker of the House of Representatives, the Governor, the Adjutant General, the Superintendent of State Police, the Director of the Office of Emergency Management, and a representative of the Department of Justice appointed by the Attorney General. The purpose of the council is to be briefed on security matters and to advise state agencies with responsibility for security matters on the future direction of the

office's planning, preparedness, response and recovery activities.

House Bill 2927 renames the Office of Emergency Management and Office of the State Fire Marshal, and establishes each as an independent state agency. The measure also creates the Emergency Preparedness Advisory Council and the Local Government Emergency Management Advisory Council.
