Appointments

RESPIRATORY THERAPIST AND POLYSOMNOGRAPHIC LICENSING BOARD

The Governor has appointed the following individual to the Respiratory Therapist and Polysomnographic Licensing Board subject to Senate confirmation.¹

Appointees

Michael Erickson of Hermiston; New Appointment

Statement of Economic Interest²

Not required.

Statutory Requirements³

The board consists of seven members appointed by the Governor and subject to confirmation by the Senate.⁴ All members of the board must be residents of this state. Board members may be selected by the Governor from a list of three to five nominees for each vacancy, submitted by the Oregon Society for Respiratory Care or another professional organization representing respiratory care practitioners or polysomnographic technologists. Members serve four-year terms and at the pleasure of the Governor.

Membership must include:

- Three members who are respiratory care practitioners (ERICKSON, HULSE, WOODMAN). These members must have engaged in the practice of respiratory care for a period of five or more years immediately preceding appointment to the board.
- Two members who are individuals who practice polysomnography (EASBEY, ESPINOZA). These members must have engaged in the practice of polysomnography for a period of five or more years immediately preceding appointment to the board.

- One member who is a qualified medical director for polysomnography or for respiratory care (LEFOR).
- One member who is a member of the general public (HERRERA-FUENTES).

The board must select one of its members as chairperson and another as vice chairperson, for those terms and with duties and powers necessary for the performance of the functions of those offices as the board determines.

Duties and Authority

The board oversees the practices of respiratory therapists and polysomnographic technologists in the State of Oregon.⁵ The board must:⁶

- establish standards of practice and professional responsibility for persons licensed by the office; and
- provide for waivers of examinations, grandfathering requirements and temporary licenses as considered appropriate.
