### **OREGON BOARD OF DENTISTRY**

The Governor has appointed the following individuals to the Oregon Board of Dentistry subject to Senate confirmation.<sup>1</sup>

### **Appointee**

Chip Dunn of Happy Valley; Reappointment Sheena Kansal of Portland; New Appointment Alicia Riedman of Eugene; Reappointment

Dunn: April 1, 2021 – March 31, 2025 Kansal: April 19, 2021 – March 31, 2025 Riedman; April 1, 2021 – March 31, 2024

# **Statutory Requirements**<sup>3</sup>

The board consists of 10 members appointed by the Governor and subject to confirmation by the Senate.<sup>4</sup> All members of the board must be residents of this state. Members serve four-year terms and at the pleasure of the Governor.

Six members must be Oregon active licensed dentists, of which at least one must be a dentist practicing in a dental specialty recognized by the American Dental Association (FINE, JAVIER, KALLURI, KANSAL, SHARIFI, UNDERHILL).

Two members must be Oregon active licensed dental hygienists (MARTINEZ, RIEDMAN).

Two members must be members of the public who are not otherwise eligible for appointment to the board or a spouse, domestic partner, child, parent or sibling of a dentist or dental hygienist (BRIXEY, **DUNN**).

Board members required to be Oregon active licensed dentists or dental hygienists may be selected by the Governor from a list of three to five nominees for each vacancy, submitted by:

- the Oregon Dental Association, if the vacancy is in a dentist position;
- the Oregon Dental Hygienists' Association, if the vacancy is in a dental hygienist position; or
- any of the professional organizations representing a dental specialty, if the vacancy is in a dental specialty position.

### **Duties and Authority**

The board is authorized to:5

- elect from its membership a president;
- make disbursements from the Oregon Board of Dentistry Account;
- employ staff as necessary for the investigation and enforcement of violations;
- conduct examinations for applicants for license to practice dentistry and dental hygiene;
- make and enforce rules necessary for the procedure of the board, for the conduct of examinations, for regulating the practice of dentistry including the administration of general anesthesia and conscious sedation, and for regulating the services of dental hygienists and dental auxiliary personnel;
- initiate and conduct investigations of and hearings on all matters relating to the practice of dentistry, the discipline of licensees, or pertaining to the enforcement of any provision; and
- appoint a consultant or a committee or committees to study and report to the board the
  condition of and dental treatment rendered to any person or persons by any licensed
  dentist or dentists in this state or by any person purporting to practice dentistry in this
  state.
