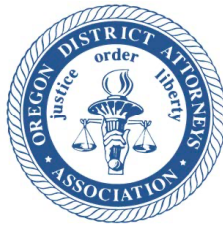

Re: ODAA Response to Public Safety Subcommittee SB 5512 Hearing Questions

Dear Co-Chairs Gorsek and Sollman:

During the Public Hearing on SB 5512, the District Attorneys and their Deputies budget bill, Oregon District Attorneys Association President Paige Clarkson and Executive Director Michael Wu testified about the roles and duties that District Attorneys fulfill in Oregon's Justice system. Members of the subcommittee, during the hearing, requested further information from the Association regarding four topics discussed during the hearing. The Association is including the requested information in this letter.

1. The Association was asked to provide information regarding the secure data storage system being developed for the long-term storage of Grand Jury audio recordings. This was requested to help aid discussions regarding a system for the long-term storage of police worn body cameras. Currently, District Attorneys are working with the Department of Justice and Microsoft to design and test the system for long-term storage. The design process is still ongoing, but the Association will provide to the subcommittee the details regarding the finished storage system once it has been completed.
2. The Association was asked to provide information about the number of felonies and misdemeanors filed by District Attorney Offices statewide. Specifically, the question was whether more misdemeanors were filed than felonies. Attached to this letter is data from the Oregon Department of Justice from 2019 and 2020 which contains the requested information. The information includes both statewide and county by county data. The Association is including 2019 data because it was the last year of data that would not have been affected by the COVID pandemic. The number of misdemeanors filed was greater than the number of felonies in both 2019 and 2020.
3. The Association was asked to provide information about what, if any, trainings the Association had provided for District Attorneys regarding bias, particularly implicit bias. In 2020 the Association provided the following trainings on bias:



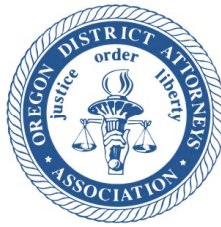
1. Barriers to Equity, by Dr. Erik Girvan, University of Oregon. Dr. Girvan was recommended by the Multnomah County District Attorney, Mike Schmidt, and instructed on his core area of research about how stereotypes, attitudes, and other biases might impact decisions in the legal system.
2. Bias Crimes Prosecution, by BJ Park, Multnomah County DAs Office. Deputy DA Park is an experienced Bias Crimes prosecutor and instructed on his experiences in this field.
3. How Interpretation Influences Evidence, by Edward Alletto, Gillian Fischer and Melanie DeLeon. The instruction was on how prosecutors can be more mindful of the challenges that those who need access to an interpreter face when they encounter the justice system. Instruction covered how to support court interpreters in their duties, how to navigate evidentiary issues related to interpreters and how to better phrase questions in English that will be more effective in the non-English language.

Additionally, the Association is planning on trainings regarding Bias crimes and their effect on our communities as a key component of our Summer Conference. The Association plans on having presentations on the Oregon Department of Justice's Civil Rights unit and how prosecutors can work with them, Building Bridges of Understanding in our Communities will present on what tools are available for prosecutors to build more trust with marginalized communities, a speaker from the United States Department of Justice's Civil Rights Division, and a presentation on Asian American and Pacific Islander hate crimes and what prosecutors can do to address its rise.

4. The Association was asked to provide information about why only 22 of 36 District Attorney Offices provide child support services. Specifically, the Association was asked for clarification as to why 14 offices do not provide these services.

As noted by ODAA President Clarkson during her testimony, the decision to offer child support services through a county's district attorney office is a county-level decision. The counties that have ceased their programs are predominately rural counties with smaller populations. There are several common factors that have typically impacted counties' decisions to cease child support programs through their district attorney offices, including the following:

- Hiring/staffing: Many of the counties no longer providing child support services had few or only part-time staff who performed the child support work. When experienced staff retire, it can be difficult for small offices to identify suitable replacements and have continuing staff available to train the replacement staff.
- Complex subject matter: The Oregon Child Support Program is a part of a larger, federally-mandated and partially funded grant program. Child support operations involve technical knowledge of family law, statutes and administrative rules, enforcement principals, and the program's ever-evolving business processes. Maintaining current knowledge of these areas requires significant attention and continual balancing of these responsibilities with other district attorney office functions. Offices with programs



must train staff to deal with these unique issues.

- Program Funding: Child support offices receive federal reimbursement for a portion of the costs to operate their programs. As is common with other federal grant programs, there are detailed accounting requirements for the program. This can be an issue for offices carrying very small caseloads but have the same administrative burden as larger counties.
- Budget: There have been periods of extreme fiscal austerity for some counties in the past years. Some counties have had to make severe cuts to their essential services' budgets, including decisions to end management of their child support programs, despite the fact the program is well regarded as directly benefitting families within the communities.

The 22 district attorney offices that continue to offer child support programs are especially proud of their high level of customer service and their role in providing local delivery of services to constituents. Most recently, our offices have made operational changes to maintain continuity of services during the pandemic. In the last couple of years, our offices have also contributed to the successful multi-year transition of the program to its new child support enforcement automated system, Origin.
