# **PUC Background**


PUC regulates investor-owned utilities, including PacifiCorp, Portland General Electric and Idaho Power Company

Serves as Economic Regulator

- Mission to ensure utilities provide safe and reliable service at just and reasonable rates
- Expects the regulated utilities to proactively manage all safety and reliability risks
- Uses ratemaking authority to provide incentives, including performance-based recovery of costs









# Wildfire Risk – Call to Action







Following California wildfires, PUC urgently began engaging our utilities and stakeholders on fire risk

- In 2019 and 2020, required utilities to present wildfire plans: enhanced vegetation clearing, system hardening, and PSPS criteria and protocols
- In July 2019, toured Dept. of Forestry's early detection center in Southern Oregon and invited dialogue among utilities, elected leaders, and emergency planners
- January 2021, entered MOU with Dept. of Forestry to formalize joint efforts to help prevent and mitigate fire risk

# **EO 20-04 Climate Action**

<u>Governor's EO 20-04</u> included two directives to the PUC regarding wildfire risk

- Convene workshops to help all operators of transmission and distribution systems to develop and share best practices for mitigating wildfire risk
- Evaluate regulated utilities risk-based wildfire protection plans and planed activities to protect public safety





## Oregon Wildfire Electric Collaborative (OWEC)


Four workshops to discuss technical wildfire mitigation issues and best practices

- 2021 Wildfire Season Forecast and Situational Awareness Tools and Modeling



### Wildfire Prevention and Mitigation Plans





#### Temporary Rules for 2021 Wildfire Season

- Focused on PSPS protocols and fire-related incident reporting
- Approved May 18

#### Wildfire Mitigation Plan Rulemaking (AR 638)

- Vegetation management, wildfire risk analyses, community engagement, PSPS protocols, system hardening, cost-benefit analysis methodology
- Continuing to meet throughout the summer on key issues
- Proposed rules targeted for Jan 2022; final rules Q2 2022
