


Reinforce Geographic Disparities

- Future looks like the past



Local housing needs projections reinforce geographic disparities



Portland Metro




Willamette Valley




Results of Current System

Rent burden by selected demographics, Oregon



**House Bill 2003 and the Housing
Production Strategy**

“The state’s housing crisis has continued for far too long and demands a **bold set of solutions** from the Legislature... We must publicly finance **more affordable housing** across Oregon. We must create more **housing choice in exclusively single-family neighborhoods**. And we must smooth the way for **more construction** at the local level. This is the goal of House Bill 2003.”

House Bill 2003: a Major Step Forward

Housing Production Strategies address existing shortcomings

- Considers equitable outcomes directly
- Beyond land use to housing production
- Realistic, accountable implementation for jurisdictions

But existing Housing Needs Analysis challenges and gaps remain

- Chronically underestimating housing need
- Reinforces patterns of geographic inequity
- Housing markets are regional
- Unclear and contentious expectations for addressing housing need








Takeaway:

Recent production: **20,000 per year**


