| Special judicial panel must establish a litigation schedule | October 22, 2021 (7 days after deadline to intervene) |
| Special judicial panel determines whether to approve a plan or adopt a different plan | November 24, 2021 (40 days from deadline to intervene) |
| Appeal of special judicial panel's decision to Supreme Court | November 29, 2021 (5 days) |
| Supreme Court must establish a litigation schedule | November 30, 2021 |
| Supreme Court determination on whether to approve decision of special judicial panel or whether panel's plan must be changed | January 3, 2022 (35 days) |
