# SB 759 -3, -6 STAFF MEASURE SUMMARY

#### WHAT THE MEASURE DOES:

Directs Legislative Administrator to represent legislative department in collective bargaining negotiations with legislative department employee bargaining units. Clarifies that only state agencies within executive department are represented by the Oregon Department of Administrative Services in collective bargaining negotiations.

FISCAL: Fiscal impact statement issued (indeterminate) REVENUE: No revenue impact

## **ISSUES DISCUSSED:**

- Allowing the Legislative Administrator the authority to delegate authority similar to delegation authority in executive and judicial branches
- Guidance for Legislative Administrator and role of Legislative Administration Committee and Presiding Officers

## **EFFECT OF AMENDMENT:**

-3 Replaces Legislative Administrator with presiding officers of each house of the Legislative Assembly to represent legislative department in collective bargaining negotiations with certified or recognized exclusive representatives of all appropriate legislative department employee bargaining units. Allows presiding officers to delegate collective bargaining responsibility to a chief negotiator who, after consultation with majority party and minority party caucus leaders of Senate and House of Representatives, shall establish a bargaining team to carry out collective bargaining negotiations.

-6 Replaces Legislative Administrator with presiding officers of each house of the Legislative Assembly to represent legislative department in collective bargaining negotiations with certified or recognized exclusive representatives of all appropriate legislative department employee bargaining units. Requires presiding officers to delegate collective bargaining responsibility to a chief negotiator who, after consultation with majority party and minority party caucus leaders of Senate and House of Representatives, shall establish a bargaining team to carry out collective bargaining negotiations.

## BACKGROUND:

The Public Employee Collective Bargaining Act (PECBA) governs collective bargaining and dispute resolution processes for Oregon's public employers and unions representing public employees. PECBA is administered by the Employment Relations Board (ERB), an executive branch agency overseen by three members appointed by the Governor and subject to confirmation by the Senate.

PECBA specifies that the Department of Administrative Services represents all state agencies in collective bargaining negotiations with represented executive branch employees and that the Chief Justice of the Supreme Court represents the judicial department in collective bargaining negotiations with represented judicial department employees. The law is silent on legislative branch representation in collective bargaining negotiations

with represented legislative branch employees.

Senate Bill 759 establishes that the Legislative Administrator represents the legislative department in collective bargaining negotiations with represented legislative branch employees.
