Summary of Revenue Changes

House Bill 2004 appropriates \$9.7 million General Fund to the Department of Administrative Services (DAS) for distribution to the Oregon Community Foundation to support emergency shelters through grants to local community organizations for the acquisition, retrofitting, and operation of emergency shelters throughout the state.

Summary of Transportation and Economic Development Subcommittee Action

In 2020, the Emergency Board allocated \$65 million General Fund for the purpose of acquiring motels and hotels for use as non-congregate shelter for people experiencing or at risk of homelessness. The Oregon Community Foundation has administered the funding under contract with DAS, conducting an application and selection process with guidance from an advisory committee consisting of stakeholders at the state and local level.

Project awards to date are as follows:

- \$30 million designated for shelter opportunities in counties or tribal communities impacted by the 2020 wildfires has been fully allocated, resulting in the funding of seven projects for a total of 388 units in six counties.

- \$35 million designated for shelter opportunities in the remaining areas of the state. Of this amount, \$31.2 million has been allocated to date.

Demand for the remaining \$3.8 million in funding designated for shelter opportunities is oversubscribed. There are four potential projects in due diligence, in Deschutes, Multnomah, Malheur and Yamhill counties. The additional \$9.7 million included in this bill is needed to allow these remaining projects to proceed, which could add a combined total of 132 units of shelter.
