Summary of Revenue Changes

Senate Bill 778 appropriates \$1,376,037 General Fund to the Office of the Governor to support the newly established Office of Immigrant and Refugee Advancement.

Summary of General Government Subcommittee Action

Senate Bill 778 establishes the Office of Immigrant and Refugee Advancement (Office) within the Office of the Governor. The purpose of the Office is to develop, implement, maintain, and oversee statewide immigration and refugee programs and services that coordinate with long-term support services to meet the needs of immigrant and refugee populations in Oregon. The Office will also be responsible for collecting data on immigration and refugee populations in Oregon to determine needs to track progress in reducing social, economic, and health disparities for refugees and immigrant populations.

The bill appropriates \$1,376,037 General Fund and establishes four positions (3.83 FTE) to support the work of the Office. The Office will consist of the following four permanent, full time positions:

- Principal Executive Manager G to serve as the Director overseeing statewide strategy for immigration and refugee programs and services,
- Operations and Policy Analyst 4 to manage community partnerships,
- Operations and Policy Analyst 4 to manage data collection and research, and
- Executive Support Specialist 2 to provide administrative support for the Office.
