Measure Description:

Requires every public education provider to provide both tampons and sanitary pads at no cost to students.

Government Unit(s) Affected:

Community Colleges, Public Universities, Higher Education Coordinating Commission (HECC), Department of Education (ODE), School Districts

Summary of Fiscal Impact:

Analysis: The measure requires school districts, charter schools, Education Service Districts (ESDs), community colleges, and public universities to stock menstrual products in two student bathrooms in each facility for the first year of the biennium and every bathroom in the second year. The Other Funds in this program are a distribution or carve-out from the State School Fund (SSF) and identified as Grants-in-Aid for the Oregon Department of Education. The measure has a blank amount for the distribution from the SSF. This fiscal assumes that the State School Fund is not increased to cover the amount of the distribution.

The Oregon Department of Education has estimated that the initial set-up of dispenser will cost \$1,075,000 for 5,000 dispensers and ongoing maintenance and supplies will cost \$4,520,000 per year or \$9,040,000 per biennia. LFO assumes the increase in the second year of the biennium reflects the increase in the number of bathrooms the requirement apples to at each school in the second year. ODE will also need one Operations and Policy Analyst 3 (0.50 FTE) for rule writing, program development and implementation, grant payment processing, providing technical support, and compliance checks. ODE costs also include costs of technical assistance to school districts.

The public universities estimate installing dispensers will cost \$431,279 and ongoing supplies will cost \$517,680 per biennia. These costs would come out of the pubic university support fund. Community Colleges anticipate \$96,150 in one-time costs and \$709,438 in recurring biennial costs. These costs would come out of the Community College Support Fund. LFO notes that the amount required for community colleges and public universities are to be funded from their respective support funds, but it is unclear whether the amount is to be deducted from the support funds and paid to colleges and universities as a separate payment by the Higher

Education Coordinating Commission. This fiscal assumes that the two support funds are not increased to cover the costs of the meeting the requirements of the bill.

The measure transfers \$5,595,000 from the State School Fund to be used for Grants-in-Aid and appropriates \$137,483 General Fund to the Department of Education to administer the program.
