Summary of Revenue Changes

HB 3103 makes a one-time General Fund appropriation of \$485,100 to the Oregon Water Resource Department (WRD) to carry out the provisions of the bill.

Summary of Natural Resource Subcommittee Action

HB 3101 allows the holder of a water right certificate that authorizes water storage to change the type of use identified in the water right without losing priority of the right itself. The funding provided in the bill will be used by the Water Resources Commission to engage in professional facilitation services, design a process for stakeholder meetings, and hold six to 12 meetings with at least 20 diverse stakeholders between the effective date of the Act and June 30, 2023. The purpose of the meetings is to find stakeholder agreement on a path forward for transfers of stored water and related legislative proposals.
