Summary of Revenue Changes

HB 3092 establishes the Domestic Well Remediation Fund and appropriates \$500,000 General Fund to the Water Resources Department (WRD) for deposit into the fund.

Summary of Natural Resources Subcommittee Action

HB 3092 establishes a grant program, within WRD, for the purposes of remediating reductions in groundwater use for domestic personal use in the Greater Harney Groundwater Area of Concern. WRD may award grants for costs related to replacement repair or deepening of wells, within criteria established in the bill, and allows WRD to adopt rules. The measure also establishes the Domestic Well Remediation Fund Separate from the General Fund and continuously appropriates funds to the account. The Subcommittee recommended a one-time appropriation of \$500,000 to WRD for deposit in the account.
