

## HOUSE AMENDMENTS TO HOUSE BILL 2004

1 In line 2 of the printed bill, before the period insert “; and declaring an emergency”.

2 Delete lines 4 through 8 and insert:

3 **“SECTION 1. In addition to and not in lieu of any other appropriation, there are appro-**  
4 **priated to the Housing and Community Services Department, for deposit into the Housing**  
5 **and Community Services Department Revolving Account under ORS 456.574, for the**  
6 **biennium beginning July 1, 2021, out of the General Fund, the following amounts:**

7 **“(1) \$27,000,000 for grants under section 9, chapter \_\_, Oregon Laws 2021 (Enrolled House**  
8 **Bill 2006); and**

9 **“(2) \$2,000,000 for technical assistance under section 9, chapter \_\_, Oregon Laws 2021**  
10 **(Enrolled House Bill 2006).**

11 **“SECTION 2. In addition to and not in lieu of any other appropriation, there are appro-**  
12 **priated to the Oregon Department of Administrative Services, for the biennium beginning**  
13 **July 1, 2021, out of the General Fund, the following amounts:**

14 **“(1) \$1,500,000 to the City of McMinnville for a navigation center, pursuant to section 10,**  
15 **chapter \_\_, Oregon Laws 2021 (Enrolled House Bill 2006);**

16 **“(2) \$1,500,000 to the City of Roseburg for a navigation center pursuant to section 10,**  
17 **chapter \_\_, Oregon Laws 2021 (Enrolled House Bill 2006);**

18 **“(3) \$2,500,000 to the City of Bend for a navigation center pursuant to section 10, chapter**  
19 **\_\_, Oregon Laws 2021 (Enrolled House Bill 2006);**

20 **“(4) \$2,500,000 to the City of Medford for a navigation center pursuant to section 10,**  
21 **chapter \_\_, Oregon Laws 2021 (Enrolled House Bill 2006);**

22 **“(5) \$5,000,000 to the City of Salem for a navigation center pursuant to section 10, chapter**  
23 **\_\_, Oregon Laws 2021 (Enrolled House Bill 2006); and**

24 **“(6) \$5,000,000 to Lane County for a navigation center within the City of Eugene pursuant**  
25 **to section 10, chapter \_\_, Oregon Laws 2021 (Enrolled House Bill 2006).**

26 **“SECTION 3. Sections 1 and 2 of this 2021 Act become operative on the date that chapter**  
27 **\_\_, Oregon Laws 2021 (Enrolled House Bill 2006), becomes law.**

28 **“SECTION 4. This 2021 Act being necessary for the immediate preservation of the public**  
29 **peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect**  
30 **on its passage.”.**
