

House Bill 2071

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor Kate Brown for Oregon Health Authority)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires that Department of Revenue issue license to qualified retailers of tobacco products and inhalant delivery systems. Defines "tobacco products" and "inhalant delivery system." Allows department to impose civil penalty for specified violations. Directs department, Oregon Health Authority, local public health authorities and cities to share information for effective administration and enter into agreements for purposes of collecting fees imposed by Oregon Health Authority, local public health authorities and cities.

Allows Oregon Health Authority to impose civil penalty for violation of certain state public health and safety laws related to tobacco products and inhalant delivery systems.

Allows local public health authority or city to enforce local standards for regulation of sale of tobacco products and inhalant delivery systems or enforce state standards for regulation of sale of tobacco products and inhalant delivery systems. Prohibits city or local public health authority from adopting ordinance, after effective date of Act, to prohibit colocation of retailer of tobacco products or inhalant delivery systems with pharmacy.

Takes effect on 91st day following adjournment sine die.

4 **Be It Enacted by the People of the State of Oregon:**

TOBACCO RETAILER LICENSURE

SECTION 1. Definitions. As used in sections 1 to 15 of this 2021 Act:

9 (1) "Governing body of a local public health authority" has the meaning given that term
10 in ORS 431.003.

11 (2) "Inhalant delivery system" has the meaning given that term in ORS 431A.175.

12 (3) "Local public health authority" has the meaning given that term in ORS 431.003.

13 (4) "Premises" means the real property on which a business that makes retail sales of
14 tobacco products or inhalant delivery systems is located.

15 (5) "Tobacco products" has the meaning given that term in ORS 431A.175.

16 **SECTION 2. Purpose. The purpose of sections 1 to 15 of this 2021 Act is to improve**
17 **enforcement of local ordinances and rules, state laws and rules and federal laws and regu-**
18 **lations that govern the retail sale of tobacco products and inhalant delivery systems.**

19 **SECTION 3. Licensure requirement. A person may not make a retail sale of a tobacco**
20 **product or an inhalant delivery system at or from a premises located in this state unless the**
21 **person sells the tobacco product or inhalant delivery system at or from a premises licensed**
22 **under section 5 of this 2021 Act.**

23 **SECTION 4. Premises to which Act does not apply. Notwithstanding section 3 of this**
24 **2021 Act, sections 1 to 15 of this 2021 Act do not apply to a person making a retail sale of**

1 an inhalant delivery system at a medical marijuana dispensary registered under ORS
 2 475B.858 or at a premises for which a license has been issued under ORS 475B.105, unless the
 3 person makes a retail sale of an inhalant delivery system that contains nicotine.

4 **SECTION 5. Licensure.** (1) The Department of Revenue shall issue licenses to, and an-
 5 nually renew licenses for, a person that makes retail sales of tobacco products or inhalant
 6 delivery systems at qualified premises.

7 (2) To be qualified for licensure under this section, a premises:

8 (a) Must be a premises that is fixed, permanent and located in this state;

9 (b) May not be located in an area that is zoned exclusively for residential use; and

10 (c) Must meet any qualification for engaging in the retail sale of tobacco products and
 11 inhalant delivery systems adopted as an ordinance by a city or the governing body of a local
 12 public health authority under section 18 of this 2021 Act, provided that the department has
 13 knowledge of the qualification pursuant to an agreement entered into under section 14 of this
 14 2021 Act.

15 (3) For the purpose of licensing premises under this section, the department shall adopt
 16 rules establishing:

17 (a) Procedures for applying for and renewing licenses; and

18 (b) Licensure application, issuance and renewal fees.

19 (4) An application submitted under this section and information related to applying for
 20 or renewing a license under this section are confidential and not subject to public disclosure
 21 under ORS 192.311 to 192.478. However, the department may share an application submitted
 22 under this section and information related to applying for or renewing a license under this
 23 section with the Department of Justice, the Oregon Health Authority or with a city or a local
 24 public health authority that adopts an ordinance under section 18 of this 2021 Act.

25 (5) The Department of Revenue shall publish a list that includes the name of each person
 26 to which a license has been issued under this section, the address of each premises for which
 27 a license has been issued under this section and any other information that the department
 28 determines is relevant to the public with respect to the retail sale of tobacco products and
 29 inhalant delivery systems.

30 (6) Fees established under subsection (3)(b) of this section must be reasonably calculated
 31 not to exceed the costs associated with the department administering sections 1 to 15 of this
 32 2021 Act.

33 (7) All moneys collected under this section shall be deposited in the suspense account
 34 described in section 10 of this 2021 Act.

35 **SECTION 6. Proof of licensure.** A person to which a license has been issued under section
 36 5 of this 2021 Act must post proof of licensure in a clear and conspicuous place at the
 37 premises for which the license has been issued.

38 **SECTION 7. Revocation, suspension, refusal to issue or renew.** (1) The Department of
 39 Revenue may revoke, suspend or refuse to issue or renew a license issued under section 5
 40 of this 2021 Act if the person that holds or seeks the license, an individual who participates
 41 in the management of the premises for which the license has been or would be issued or an
 42 individual who is employed for the purpose of making retail sales at the premises:

43 (a) Violates sections 1 to 15 of this 2021 Act, a rule adopted under sections 1 to 15 of this
 44 2021 Act or any other state law or rule or federal law or regulation that governs the retail
 45 sale of tobacco products or inhalant delivery systems or state taxation;

1 (b) Violates an ordinance adopted by a city or the governing body of a local public health
2 authority or a rule adopted by a city or local public health authority that governs the retail
3 sale of tobacco products or inhalant delivery systems; or

4 (c) Makes a false statement to the department.

5 (2) The department may only revoke, suspend or refuse to issue or renew a license pur-
6 suant to subsection (1)(b) of this section if a city or local public health authority:

7 (a) Has provided the person that holds or seeks the license, the individual who partic-
8 ipates in the management of the premises for which the license has been or would be issued
9 or the individual who is employed for the purpose of making retail sales at the premises with
10 a process for contesting the violation that is substantially similar to the process provided
11 under ORS 183.413 to 183.470; and

12 (b) Provides the department with a final order that establishes the person or individual
13 is in violation of an ordinance that is substantially similar to the requirements for a final
14 order under ORS 183.470.

15 (3) Except as provided by state tax law or as otherwise identified by the department by
16 rule or order, a decision by the department to revoke, suspend or refuse to issue or renew
17 a license under this section may be appealed as a contested case under ORS chapter 183.

18 **SECTION 8. Civil penalty.** (1) The Department of Revenue may impose a civil penalty
19 against a person that holds or seeks a license issued under section 5 of this 2021 Act if the
20 person that holds or seeks the license, an individual who participates in the management of
21 the premises for which the license has been or would be issued or an individual who is em-
22 ployed for the purpose of making retail sales at the premises:

23 (a) Violates sections 1 to 15 of this 2021 Act, a rule adopted under sections 1 to 15 of this
24 2021 Act or any other state law or rule or federal law or regulation that governs the retail
25 sale of tobacco products or inhalant delivery systems or state taxation; or

26 (b) Makes a false statement to the department.

27 (2) A civil penalty imposed under this section may not exceed \$1,000 per violation.

28 (3) Amounts collected by the department under this section shall be deposited in the
29 General Fund.

30 (4) Except as provided by state tax law or as otherwise identified by the department by
31 rule or order, an imposition of a civil penalty under this section may be appealed as a con-
32 tested case under ORS chapter 183.

33 (5) If a civil penalty is imposed under this section, a civil penalty may not be imposed for
34 the commission of the same act under ORS 431A.178 or pursuant to an ordinance or rule
35 adopted under section 18 of this 2021 Act.

36 **SECTION 9. Seizure and forfeiture of contraband tobacco products and contraband**
37 **inhalant delivery systems.** (1) For purposes of this section, a tobacco product or inhalant
38 delivery system sold or held for sale at or from a premises for which a license has not been
39 issued under section 5 of this 2021 Act is a contraband tobacco product or contraband
40 inhalant delivery system.

41 (2)(a) A contraband tobacco product or contraband inhalant delivery system found by the
42 Department of Revenue or a law enforcement agency may be seized immediately by the de-
43 partment or agency and is subject to forfeiture. If seized and forfeited under this section,
44 the contraband tobacco product or the contraband inhalant delivery system must be de-
45 stroyed.

1 (b) The department or an agency may assess the actual costs incurred by the department
 2 or agency to the person responsible for the premises described in subsection (1) of this sec-
 3 tion.

4 (3) Notwithstanding ORS 305.280 or 323.416, a seizure and forfeiture made under this
 5 section may be appealed to the magistrate division of the Oregon Tax Court within 30 days
 6 of the date of the seizure in the manner provided in ORS 305.404 to 305.560.

7 **SECTION 10. Suspense account for administration and enforcement.** (1) Amounts col-
 8 lected by the Department of Revenue under section 5 of this 2021 Act shall be paid to the
 9 State Treasurer to be held in a suspense account established under ORS 293.445.

10 (2) From moneys held in the suspense account, the department may pay expenses for the
 11 administration and enforcement of sections 1 to 15 of this 2021 Act and the collection of fees
 12 under sections 1 to 15 of this 2021 Act. Refunds, including refunds of erroneous overpayments
 13 or refunds of other moneys received in which the department has no legal interest, shall be
 14 paid out of the suspense account.

15 (3) Amounts necessary to make payments as described in subsection (2) of this section
 16 are continuously appropriated to the department from the suspense account.

17 **SECTION 11. Rules.** The Department of Revenue may adopt rules necessary for the ef-
 18 fective administration of sections 1 to 15 of this 2021 Act.

19 **SECTION 12. Oregon Liquor Control Commission.** (1) The Department of Revenue and the
 20 Oregon Health Authority may request that the Oregon Liquor Control Commission assist the
 21 department and the authority in the administration and enforcement of ORS 431A.175 and
 22 431A.183 and sections 1 to 15 and 18 of this 2021 Act.

23 (2) The department, the authority and the commission may, in collaboration with one
 24 another, adopt rules to carry out this section.

25 **SECTION 13. Fees.** The Oregon Health Authority shall adopt by rule fees necessary to
 26 pay the expenses of administering and enforcing ORS 431A.175 and 431A.183 and section 18
 27 of this 2021 Act. Pursuant to an agreement entered into under section 14 of this 2021 Act,
 28 the Department of Revenue shall collect the fee moneys for, and transfer the fee moneys to,
 29 the authority. Moneys transferred to the authority under this section must be deposited in
 30 the Oregon Health Authority Fund established under ORS 413.101. Moneys deposited in the
 31 fund under this section are continuously appropriated to the authority for the purposes of
 32 administering and enforcing ORS 431A.175 and 431A.183 and section 18 of this 2021 Act.

33 **SECTION 14. Intergovernmental agreements.** (1) The Department of Revenue and the
 34 Oregon Health Authority shall:

35 (a) Share information necessary for the effective administration of ORS 431A.175 and
 36 431A.183 and sections 1 to 15 and 18 of this 2021 Act; and

37 (b) Enter into an agreement for purposes of collecting fee moneys for the authority
 38 pursuant to section 13 of this 2021 Act from each retailer of tobacco products or inhalant
 39 delivery systems at the same time that the department collects fee moneys under section 5
 40 of this 2021 Act from the retailer, and transferring the fee moneys collected pursuant to
 41 section 13 of this 2021 Act to the authority for deposit in the Oregon Health Authority Fund
 42 established under ORS 413.101.

43 (2) The Department of Revenue, and each city and local public health authority that
 44 adopts an ordinance pursuant to section 18 of this 2021 Act, shall:

45 (a) Share information necessary for the effective administration of sections 1 to 15 and

1 18 of this 2021 Act; and

2 (b) Enter into an agreement for purposes of collecting any fee moneys for the city or
 3 local public health authority pursuant to section 18 of this 2021 Act from each retailer of
 4 tobacco products or inhalant delivery systems located within the area over which the city
 5 or local public health authority has jurisdiction at the same time that the department col-
 6 lects fee moneys under section 5 of this 2021 Act from the retailer, and transferring the fee
 7 moneys collected pursuant to section 18 of this 2021 Act to the city or local public health
 8 authority for deposit in a fund of the city or local public health authority.

9 (3) The Oregon Health Authority, and each city and local public health authority that
 10 adopts an ordinance pursuant to section 18 of this 2021 Act, shall share information neces-
 11 sary for the effective administration of ORS 431A.175 and 431A.183 and sections 1 to 15 and
 12 18 of this 2021 Act.

13 **SECTION 15. Suspense account for fee money transfers.** (1) Amounts collected by the
 14 Department of Revenue pursuant to agreements entered into under section 14 of this 2021
 15 Act shall be paid to the State Treasurer to be held in a suspense account established under
 16 ORS 293.445.

17 (2) From moneys held in the suspense account, the department shall make transfers to
 18 the Oregon Health Authority, cities and local public health authorities as required by section
 19 14 of this 2021 Act.

20 (3) Amounts necessary to make transfers as described in subsection (2) of this section
 21 are continuously appropriated to the department from the suspense account.

 23 **STATE PUBLIC HEALTH AND SAFETY LAWS**
 24

25 **SECTION 16.** ORS 431A.178 is amended to read:

26 431A.178. [(1) *The Oregon Health Authority may impose a civil penalty for each violation of ORS*
 27 *431A.175. A civil penalty imposed under this section may not be less than \$250 or more than \$1,000.*]

28 (1) **The Oregon Health Authority may impose a civil penalty against a person that en-**
 29 **gages in the wholesale or retail sale of tobacco products or inhalant delivery systems, as**
 30 **those terms are defined in ORS 431A.175, if the person violates:**

31 (a) **ORS 431A.175 or a rule adopted under ORS 431A.175; or**

32 (b) **A state law or rule or federal law or regulation that governs the wholesale or retail**
 33 **sale of tobacco products or inhalant delivery systems for purposes related to public health**
 34 **and safety.**

35 (2) **A civil penalty imposed under this section may not be more than \$5,000 per violation.**

36 [(2)(a) *Amounts collected under subsection (1) of this section shall be deposited in the Oregon*
 37 *Health Authority Fund established under ORS 413.101. Except as provided in paragraph (b) of this*
 38 *subsection, moneys deposited in the fund under this subsection are continuously appropriated to the*
 39 *authority for carrying out the duties, functions and powers of the authority under ORS 431A.175 and*
 40 *431A.183.*]

41 [(b) *At the end of each biennium, the authority shall transfer the unobligated moneys collected*
 42 *under subsection (1) of this section remaining in the fund to the Tobacco Use Reduction Account es-*
 43 *tablished under ORS 431A.153.*]

44 (3) **Amounts collected under this section shall be deposited in the General Fund.**

45 (4) **If a civil penalty is imposed under this section, a civil penalty may not be imposed for**

1 **the commission of the same act under section 8 or 18 of this 2021 Act.**

2 **SECTION 17.** ORS 431A.183 is amended to read:

3 431A.183. (1)(a) The Oregon Health Authority may enter into an agreement with federal agencies
4 to assist the authority in monitoring and enforcing federal laws and regulations related to tobacco
5 products or inhalant delivery systems.

6 (b) The authority may commission employees of the authority as federal officers for the purpose
7 of carrying out the duties prescribed under an agreement entered into under paragraph (a) of this
8 subsection.

9 (c) The authority may adopt rules and take any action necessary to carry out the authority's
10 duties as established under an agreement entered into under paragraph (a) of this subsection.

11 (2)(a) The authority may enter into an agreement with federal, state and local government
12 agencies, including federal, state and local law enforcement agencies, to assist the authority in
13 carrying out the authority's duties under ORS 431A.175 and to conduct random, unannounced in-
14 spections of wholesalers and retailers of tobacco products or inhalant delivery systems to ensure
15 compliance with the laws of this state designed to discourage the use of tobacco products and
16 inhalant delivery systems by persons under 21 years of age, including ORS 167.750, 167.755, 167.760,
17 167.765, 167.775, 167.780 and 431A.175.

18 **(b) The authority shall ensure that a retailer is inspected as described in this subsection**
19 **at least once each year.**

20 (3)(a) If the authority enters into an agreement with the Department of State Police under sub-
21 section (2) of this section, the department may employ retired state police officers who are active
22 reserve officers. Service by a retired state police officer under this paragraph is subject to ORS
23 238.082.

24 (b) The department may not use the services of a retired state police officer to displace an ac-
25 tive state police member.

26 (4)(a) The authority may apply for and accept moneys from the federal government or other
27 public or private sources and, in accordance with any federal restrictions or other funding source
28 restrictions, use those moneys to carry out the duties and functions related to preventing the use
29 of tobacco products or inhalant delivery systems by persons who are not of the minimum age to
30 purchase tobacco products or inhalant delivery systems.

31 (b) Moneys received by the authority under paragraph (a) of this subsection shall be deposited
32 in the Oregon Health Authority Fund established under ORS 413.101. Moneys subject to a federal
33 restriction or other funding source restriction must be accounted for separately from other fund
34 moneys.

35 (5)(a) The authority shall submit a written report each biennium to the Governor and to the
36 appropriate committee or interim committee of the Legislative Assembly to which matters of public
37 health are assigned.

38 (b) The report submitted under this subsection must contain information describing:

39 (A) The activities carried out to enforce the laws listed in subsection (2) of this section during
40 the previous biennium;

41 (B) The extent of success achieved in reducing the availability of tobacco products and inhalant
42 delivery systems to persons under 21 years of age; and

43 (C) The strategies to be utilized for enforcing the laws listed in subsection (2) of this section
44 during the biennium following the report.

45 (6) The authority shall adopt rules for conducting random inspections of establishments that

1 distribute or sell tobacco products or inhalant delivery systems. The rules shall provide that in-
 2 spections may take place:

3 *[(a) Only in areas open to the public;]*

4 *[(b)]* (a) Only during the hours that tobacco products or inhalant delivery systems are distrib-
 5 uted or sold; and

6 *[(c)]* (b) No more frequently than once a month in any single establishment unless a compliance
 7 problem exists or is suspected.

 9 **LOCAL REGULATION**

10
 11 **SECTION 18. (1) As used in this section:**

12 (a) **“Governing body of a local public health authority” has the meaning given that term**
 13 **in ORS 431.003.**

14 (b) **“Inhalant delivery system” has the meaning given that term in ORS 431A.175.**

15 (c) **“Local public health authority” has the meaning given that term in ORS 431.003.**

16 (d) **“Tobacco products” has the meaning given that term in ORS 431A.175.**

17 (2) **Each city and local public health authority may:**

18 (a) **Enforce, pursuant to an ordinance adopted by the city or the governing body of the**
 19 **local public health authority, standards for regulating the retail sale of tobacco products and**
 20 **inhalant delivery systems for purposes related to public health and safety in addition to the**
 21 **standards described in paragraph (b) of this subsection, including qualifications for engaging**
 22 **in the retail sale of tobacco products or inhalant delivery systems that are in addition to the**
 23 **qualifications described in section 5 of this 2021 Act;**

24 (b)(A) **Administer and enforce standards established by state law or rule relating to the**
 25 **regulation of the retail sale of tobacco products and inhalant delivery systems for purposes**
 26 **related to public health and safety if the city or the local public health authority and the**
 27 **Oregon Health Authority enter into an agreement pursuant to ORS 190.110; or**

28 (B) **Perform the duties described in this section in accordance with ORS 431.413 (2) or (3);**
 29 **and**

30 (c) **Use outreach and educational services to provide businesses that engage in the retail**
 31 **sale of tobacco products or inhalant delivery systems with information pertaining to local**
 32 **ordinances and rules, state laws and rules and federal laws and regulations regulating the**
 33 **retail sale of tobacco products and inhalant delivery systems.**

34 (3)(a) **A city or local public health authority may impose on businesses that engage in the**
 35 **retail sale of tobacco products or inhalant delivery systems a fee for paying the expenses of**
 36 **activities described in subsection (2) of this section. Pursuant to an agreement entered into**
 37 **under section 14 of this 2021 Act, the Department of Revenue shall collect the fee moneys**
 38 **for, and transfer the fee moneys to, the city or local public health authority. Moneys trans-**
 39 **ferred to a city or local public health authority under this subsection must be deposited in**
 40 **a fund of the city or local public health authority. Moneys deposited in a fund under this**
 41 **subsection may only be spent by the city or local public health authority for the purposes**
 42 **of subsection (2) of this section.**

43 (b)(A) **The governing body of a local public health authority may, pursuant to ORS**
 44 **431.415, establish a schedule for the fees described in paragraph (a) of this subsection.**

45 (B) **A city may establish a schedule for the fees described in paragraph (a) of this sub-**

1 section.

2 (4) A city or local public health authority may impose a civil penalty not to exceed \$5,000
3 on a business that engages in the retail sale of tobacco products or inhalant delivery systems
4 for violating a standard described in subsection (2) of this section. If a civil penalty is im-
5 posed under this section, a civil penalty may not be imposed for the commission of the same
6 act under ORS 431A.178 or section 8 of this 2021 Act.

7 (5) The Oregon Health Authority shall:

8 (a) Ensure that state standards established by state law and rule regarding the regu-
9 lation of the retail sale of tobacco products and inhalant delivery systems are administered
10 and enforced consistently throughout this state;

11 (b) Establish a database or other mechanism for collecting information from cities and
12 local public health authorities and the general public regarding the regulation of the retail
13 sale of tobacco products and inhalant delivery systems for purposes related to public health
14 and safety, including any information related to complaints about a person that makes retail
15 sales of tobacco products or inhalant delivery systems;

16 (c) Provide technical assistance to cities and local public health authorities regarding the
17 regulation of the retail sale of tobacco products and inhalant delivery systems;

18 (d) Assess the effectiveness of state and local programs for regulating the retail sale of
19 tobacco products and inhalant delivery systems; and

20 (e) Adopt any rules necessary to implement or administer the provisions of this section.

21 (6)(a) A city or local public health authority may not adopt an ordinance that prohibits
22 a premises that makes retail sales of tobacco products or inhalant delivery systems from
23 being located at the same address as a pharmacy, as defined in ORS 689.005.

24 (b) A city or local public health authority that, on or before the effective date of this 2021
25 Act, adopted an ordinance described in paragraph (a) of this subsection may continue to en-
26 force the ordinance on and after the effective date of this 2021 Act.

30 SECTION 19. Repeal. ORS 431A.180 is repealed.

32 MISCELLANEOUS

34 SECTION 20. Continuity. A city, governing body of a local public health authority or local
35 public health authority that, on or before the operative date specified in section 23 of this
36 2021 Act, enforces standards described in section 18 (2)(a) of this 2021 Act may continue to
37 enforce the standards on and after the operative date specified in section 23 of this 2021 Act.

38 SECTION 21. Applicability. The amendments to ORS 431A.178 by section 16 of this 2021
39 Act apply to violations for conduct occurring on or after the operative date specified in sec-
40 tion 23 of this 2021 Act.

44 SECTION 22. Unit and section captions. The unit and section captions used in this 2021
45 Act are provided only for the convenience of the reader and do not become part of the stat-

1 utory law of this state or express any legislative intent in the enactment of this 2021 Act.

3 **OPERATIVE AND EFFECTIVE DATES**

4
5 **SECTION 23. Operative date.** (1) Sections 1 to 15 and 18 of this 2021 Act, the amendments
6 to ORS 431A.178 and 431A.183 by sections 16 and 17 of this 2021 Act and the repeal of ORS
7 431A.180 by section 19 of this 2021 Act become operative on January 1, 2022.

8 (2) The Department of Revenue, the Oregon Health Authority, the Oregon Liquor Control
9 Commission, local public health authorities and cities may take any action before the oper-
10 ative date specified in subsection (1) of this section that is necessary to enable the depart-
11 ment, the Oregon Health Authority, the commission, local public health authorities and
12 cities to exercise, on and after the operative date specified in subsection (1) of this section,
13 all the duties, functions and powers conferred on the department, the Oregon Health Au-
14 thority, the commission, local public health authorities and cities by sections 1 to 15 and 18
15 of this 2021 Act, the amendments to ORS 431A.178 and 431A.183 by sections 16 and 17 of this
16 2021 Act and the repeal of ORS 431A.180 by section 19 of this 2021 Act.

17 **SECTION 24.** This 2021 Act takes effect on the 91st day after the date on which the 2021
18 regular session of the Eighty-first Legislative Assembly adjourns sine die.
