SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies Health Care Cost Growth Target program and Health Care Cost Growth Target Implementation Committee.

Directs Oregon Health Authority to adopt schedule of civil penalties for providers or payers that fail to report cost growth data or to develop and implement performance improvement plan if required to do so.

5 **SECTION 1.** ORS 442.385 is amended to read:

in this state. 1 2 [(3) "Health care cost growth benchmark" means the target percentage for health care cost growth.] 3 [(4)] (3) "Health care entity" means a payer or a provider. 4 [(5)] (4) "Health insurance" has the meaning given that term in ORS 731.162. 5 [(6)] (5) "Net cost of private health insurance" means the difference between health insurance 6 premiums received by a payer and the claims for the cost of health care paid by the payer under a 7 policy or certificate of health insurance. 8 9 [(7)] (6) "Payer" means: 10 (a) An insurer offering a policy or certificate of health insurance or a health benefit plan as defined in ORS 743B.005; 11 12(b) A publicly funded health care program, including but not limited to Medicaid, Medicare and 13 the State Children's Health Insurance Program; (c) A third party administrator; and 14 15 (d) Any other public or private entity, other than an individual, that pays or reimburses the cost for the provision of health care. 16 [(8)] (7) "Provider" means an individual, organization or business entity that provides health 17care. 18 19 [(9)] (8)(a) "Total health expenditures" means all health care expenditures [in] on behalf of residents of this state by public and private sources, including: 20[(a)] (A) All payments on providers' claims for reimbursement of the cost of health care pro-2122vided; 23[(b)] (B) All payments to providers other than payments described in [paragraph (a)] subparagraph (A) of this [subsection] paragraph; 24[(c)] (C) All cost-sharing paid by residents of this state, including but not limited to copayments, 25deductibles and coinsurance; and 2627[(d)] (D) The net cost of private health insurance. (b) "Total health expenditures" may include expenditures for care provided to out-of-28state residents by in-state providers to the extent practicable. 2930 SECTION 2. ORS 442.386 is amended to read: 31 442.386. (1) The Legislative Assembly intends to establish a health care cost growth [benchmark,] target, for all providers and payers, to: 32(a) Support accountability for the total cost of health care across all providers and payers, both 33 34 public and private; 35 (b) Build on the state's existing efforts around health care payment reform and containment of health care costs; and 36 37 (c) Ensure the long-term affordability and financial sustainability of the health care system in 38 this state. (2) The Health Care Cost Growth [Benchmark] Target program is established. The program shall 39 be administered by the Oregon Health Authority in collaboration with the Department of Consumer 40 and Business Services, subject to the oversight of the Oregon Health Policy Board. The program 41 shall establish a health care cost growth [benchmark] target for increases in total health expen-42 ditures and shall review and modify the [benchmark] target on a periodic basis. 43 (3) The health care cost growth [benchmark] target must: 44 (a) Promote a predictable and sustainable rate of growth for total health expenditures as meas-45

ured by an economic indicator adopted by the board, such as the rate of increase in this state's 1 2 economy or of the personal income of residents of this state; (b) Apply to all providers and payers in the health care system in this state; 3 (c) Use established economic indicators; and 4 (d) Be measurable on a per capita basis, statewide basis and health care entity basis. 5 (4) The program shall establish a methodology for calculating health care cost growth: 6 7 (a) Statewide; (b) For each provider and payer, taking into account the health status of the patients of the 8 9 provider or the beneficiary of the payer; and 10 (c) Per capita. 442.993. [(1) Any reporting entity that fails to report as required in ORS 442.373 or rules of the 10 Oregon Health Authority adopted pursuant to ORS 442.373 may be subject to a civil penalty.] 11

12[(2)] (1) The Oregon Health Authority shall adopt a schedule of civil penalties not to exceed 13 \$500 per day of violation, determined by the severity of the violation, for:

(a) Any reporting entity that fails to report as required by ORS 442.373 or rules adopted 14 15 by the authority.

16(b) Any provider or payer that fails to report cost growth data or to develop and implement a performance improvement plan if required by ORS 442.386 or rules adopted by the 17 18 authority.

[(3)] (2) Civil penalties under this section shall be imposed as provided in ORS 183.745.

[(4)] (3) Civil penalties imposed under this section may be remitted or mitigated upon such terms 20and conditions as the authority considers proper and consistent with the public health and safety. 21

22[(5)] (4) Civil penalties incurred under any law of this state are not allowable as costs for the purpose of rate determination or for reimbursement by a third-party payer. 23

(5) Moneys collected from providers and payers described in subsection (1)(b) of this 24section shall be deposited in the Oregon Health Authority Fund established by ORS 413.101 25and used by the authority to support programs that expand access to health care and that 2627support populations adversely affected by high health care costs.

SECTION 7. A financial penalty described in ORS 442.386 (9), as amended by section 2 of 28this 2021 Act, may be imposed no earlier than January 1, 2026, for performance by a provider 2930 or payer in meeting cost growth targets during calendar years 2021 to 2025.
