

HOUSE AMENDMENTS TO HOUSE BILL 2518

By COMMITTEE ON ECONOMIC RECOVERY AND PROSPERITY

1 On page 1 of the printed bill, line 2, before the period insert “; and prescribing an effective
2 date”.

3 On page 2, delete lines 43 and 44 and insert:

4 “(a) The brownfield is in a location identified in an electric vehicle infrastructure plan devel-
5 oped by the Department of Transportation and will be operated as a publicly accessible charging
6 station for electric vehicles immediately after completion.”.

7 On page 3, delete lines 19 through 26 and insert:

8 “(f) The brownfield is a developed site that became a brownfield as a direct result of
9 wildfire.”.

10 On page 4, delete lines 35 through 44 and insert:

11 **“SECTION 6. The Oregon Business Development Department shall establish by rule the
12 procedures and criteria for administration of the program established under sections 2 to 7
13 of this 2021 Act, including, but not limited to, the methods of determining:**

14 **“(1) The distribution of forgivable loans;**

15 **“(2) The amount of a forgivable loan, including enhancements listed in section 3 (3) of
16 this 2021 Act;**

17 **“(3) The terms of forgivable loan enhancements under section 3 (3) of this 2021 Act;**

18 **“(4) The conditions attached to a loan;**

19 **“(5) The circumstances in which forgivable loans must be repaid under section 5 of this
20 2021 Act; and**

21 **“(6) Any means by which noncompliance with applicable performance or other conditions
22 attached to a loan may be cured by the owner or operator.”.**

23 On page 5, delete lines 18 through 26 and insert:

24 **“SECTION 8. (1) The Oregon Business Development Department shall consider means by
25 which the department can encourage participation in removal and remedial actions that are
26 eligible for forgivable loans under sections 2 to 7 of this 2021 Act by minority-owned busi-
27 nesses, woman-owned businesses and emerging small businesses as those terms are defined
28 in ORS 200.005.**

29 **“(2) No later than January 1, 2023, the department shall submit a report in the manner
30 provided in ORS 192.245 to the interim committees of the Legislative Assembly related to
31 economic development that sets forth in detail the recipients of forgivable loans under sec-
32 tion 5 of this 2021 Act and any third parties with which the recipients contracted to complete
33 the removal and remedial actions with respect to which the forgivable loans were made.”.**

34 After line 30, insert:

35 **“SECTION 11. This 2021 Act takes effect on the 91st day after the date on which the 2021**

1 **regular session of the Eighty-first Legislative Assembly adjourns sine die.”**
