SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Clarifies permissibility of disposition of human bodies by alternative authorized processes including alkaline hydrolysis and natural organic reduction. Clarifies authority of State Mortuary and Cemetery Board to license and regulate alternative disposition facilities. Defines "alternative disposition facility."

Extends immunity from liability for reducing remains pursuant to written agreement to alternative disposition facilities. Extends requirement for further instructions as to final disposition of cremated remains to remains reduced by alternative disposition facilities.

Extends exemption from execution, appropriation for public purpose and taxation to lands held for purposes of alternative disposition facility.

Extends privilege by nonprofit corporations organized for cemetery or crematory purposes to nonprofit corporations with reduction purposes. Permits nonprofit corporations with reduction purposes to provide moneys to irreducible fund with interest and income devoted exclusively to preservation and improvement of grounds, buildings and property. Extends ability of nonprofit corporations organized for cemetery or crematory purposes to sell land unsuitable for corporation's purpose to nonprofit corporations with reduction purposes.

Extends interment and cremation recordkeeping requirements to reduction.

Extends type of funeral expenses recoverable as victim compensation for compensable crimes to expenses related to reduction.

Extends incorporated city's right to acquire, own, maintain and operate cemeteries and crematoria to acquiring, owning, maintaining and operating other authorized facilities for disposition of human remains.

Becomes operative July 1, 2022.

A BILL FOR AN ACT

Be It Enacted by the People of the State of Oregon:

DISPOSITION OF HUMAN BODIES

SECTION 1. ORS 97.010 is amended to read:

97.010. As used in ORS 97.010 to 97.040, 97.110 to 97.450, 97.510 to 97.730, 97.810 to 97.920, 97.923 to 97.949, 97.990 and 97.994:

(1) "Alkaline hydrolysis" or "hydrolysis" means the technical process for reducing human remains by placing the remains in a dissolution chamber that uses heat, pressure, water and base chemical agents, in a licensed hydrolysis facility, to reduce human remains to bone fragments and essential elements.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **(2) “Alternative disposition facility” means a structure containing equipment purposed**
2 **for reduction.**

3 [(1)] **(3)** “Burial” means the placement of human remains in a grave or lawn crypt.

4 [(2)] **(4)** “Burial park” means a tract of land for the burial of human remains, used, or intended
5 to be used, and dedicated for cemetery purposes.

6 [(3)] **(5)** “Burial right” means the right to use a grave, mausoleum, columbarium, ossuary or
7 scattering garden for the interment or other disposition of human remains.

8 [(4)] **(6)** “Cemetery” means a place:

9 (a) Dedicated to and used, or intended to be used, for a permanent memorial or the permanent
10 interment of human remains; and

11 (b) That may contain a mausoleum, crypt or vault interment, a columbarium, an ossuary, a
12 cenotaph, a scattering garden, any other structure or place used or intended to be used for the
13 interment or disposition of human remains or any combination of these structures or places.

14 [(5)] **(7)** “Cemetery association” means a corporation or association authorized by its articles
15 of incorporation to conduct the business of a cemetery, but does not include a corporation sole or
16 a charitable, eleemosynary association or corporation.

17 [(6)] **(8)** “Cemetery authority” means a person who owns or controls cemetery lands or property,
18 including but not limited to a cemetery corporation, association or corporation sole.

19 [(7)] **(9)** “Cemetery business” and “cemetery purpose” are used interchangeably and mean any
20 business or purpose requisite or incident to, or necessary for establishing, maintaining, operating,
21 improving or conducting a cemetery, interring human remains, and the care, preservation and
22 embellishment of cemetery property.

23 [(8)] **(10)** “Cemetery merchandise” means personal property offered for sale or sold for use in
24 connection with the final disposition, memorialization or interment of human remains. “Cemetery
25 merchandise” includes, but is not limited to, an outer burial container and a memorial.

26 [(9)] **(11)** “Cemetery services” means services provided by a cemetery authority for interment
27 or scattering, and installation of cemetery merchandise.

28 [(10)] **(12)** “Cenotaph” means a place, the primary purpose of which is to provide an area where
29 a person may pay to establish a memorial to honor a person whose remains may be interred else-
30 where or whose remains cannot be recovered.

31 [(11)] **(13)** “Columbarium” means a structure or room containing receptacles for permanent
32 inurnment of cremated **or reduced** remains in a place used, or intended to be used, and dedicated
33 for cemetery purposes.

34 [(12)] **(14)** “Cremated remains” means the remains of a cremated human body after completion
35 of the cremation process.

36 [(13)] **(15)** “Cremation” means the technical process, using direct flame and heat, that reduces
37 human remains to bone fragments.

38 [(14)] **(16)** “Crematory” means a structure containing a retort for the reduction of bodies of de-
39 ceased persons to cremated remains.

40 [(15)] **(17)** “Crypt” or “vault” means a space in a mausoleum of sufficient size used, or intended
41 to be used, to entomb uncremated **or uncremated** human remains.

42 [(16)] **(18)** “Directors” or “governing body” means the board of directors, board of trustees or
43 other governing body of a cemetery association.

44 [(17)] **(19)** “Endowment care” means the general care and maintenance of developed portions of
45 a cemetery and memorials erected thereon financed from the income of a trust fund.

1 [(18)] (20) "Entombment" means the placement of human remains in a crypt or vault.

2 [(19)] (21) "Funeral merchandise" means personal property offered for sale or sold for use in
3 connection with funeral services. "Funeral merchandise" includes, but is not limited to, acknowl-
4 edgment cards, alternative containers, caskets, clothing, cremation containers, cremation interment
5 containers, flowers, memory folders, monuments, outer burial containers, prayer cards, register
6 books and urns.

7 [(20)] (22) "Funeral services" means services customarily provided by a funeral service practi-
8 tioner including, but not limited to, care and preparation of human remains for final disposition,
9 professional services relating to a funeral or an alternative to a funeral, transportation of human
10 remains, limousine services, use of facilities or equipment for viewing human remains, visitation,
11 memorial services or services that are used in connection with a funeral or alternative to a funeral,
12 coordinating or conducting funeral rites or ceremonies, and other services provided in connection
13 with a funeral, alternative to a funeral or final disposition of human remains.

14 [(21)] (23) "Grave" means a space of ground in a burial park used, or intended to be used, for
15 burial of the remains of one person.

16 [(22)] (24) "Human remains" or "remains" means the body of a deceased person in any stage of
17 decomposition or after cremation **or reduction**.

18 [(23)] (25) "Interment" means the disposition of human remains by inurnment, entombment or
19 burial.

20 [(24)] (26) "Inurnment" means the placement of cremated **or reduced** remains in a receptacle
21 and the deposit of the receptacle in a niche.

22 [(25)] (27) "Lot," "plot" or "burial space" means space in a cemetery owned by one or more in-
23 dividuals, an association or fraternal or other organization and used, or intended to be used, for the
24 permanent interment therein of the remains of one or more deceased persons. Such terms include
25 and apply with like effect to one, or more than one, adjoining grave, crypt, vault or niche.

26 [(26)] (28) "Mausoleum" means a structure substantially exposed above ground for the
27 entombment of human remains in crypts or vaults in a place used, or intended to be used, and ded-
28 icated for cemetery purposes.

29 [(27)] (29) "Memorial" means a product, other than a mausoleum or columbarium, used for
30 identifying an interment space or for commemoration of the life, deeds or career of a decedent in-
31 cluding, but not limited to, an ossuary, monument, marker, niche plate, urn garden plaque, crypt
32 plate, cenotaph, marker bench or vase.

33 (30) "**Natural organic reduction**" means the contained, accelerated conversion of human
34 remains to soil.

35 [(28)] (31) "Niche" means a recess usually in a columbarium used, or intended to be used, for
36 the inurnment of the cremated **or reduced** remains of one or more persons.

37 [(29)] (32) "Ossuary" means a receptacle used for the communal placement of cremated **or re-**
38 **duced** remains without benefit of an urn or any other container in which cremated **or reduced** re-
39 mains may be commingled with other cremated **or reduced** remains and are nonrecoverable.

40 [(30)] (33) "Plot owner" or "owner" means any person identified in the records of the cemetery
41 authority as owner of the burial rights to a burial plot, or who holds a certificate of ownership
42 conveyed from the cemetery authority of the burial rights in a particular lot, plot or space.

43 (34) "**Reduced remains**" means the remains of a human body after completion of re-
44 **duction**.

45 (35) "**Reduction**" means alkaline hydrolysis, natural organic reduction and any other

1 **method of final disposition of human remains authorized by the State Mortuary and Ceme-**
2 **tery Board.**

3 [(31)] (36) "Scattering" means the lawful dispersion of cremated **or reduced** remains that need
4 not be associated with an interment right or issuance of a deed, that may be recorded only as a
5 service that has taken place and may not be recorded on the permanent records of the cemetery
6 authority.

7 [(32)] (37) "Scattering garden" means a location set aside within a cemetery that is used for the
8 spreading or broadcasting of cremated **or reduced** remains that have been removed from their
9 container and can be mixed with or placed on top of the soil or ground cover or buried in an
10 underground receptacle on a commingled basis and that are nonrecoverable.

11 [(33)] (38) "Special care" means any care in excess of endowed care in accordance with the
12 specific directions of a donor of funds.

13 **SECTION 2.** ORS 97.130 is amended to read:

14 97.130. (1) Any individual of sound mind who is 18 years of age or older, by completion of a
15 written signed instrument or by preparing or prearranging with any funeral service practitioner li-
16 censed under ORS chapter 692, may direct any lawful manner of disposition of the individual's re-
17 mains. Except as provided under subsection (7) of this section, disposition directions or disposition
18 prearrangements that are prepaid or that are filed with a funeral service practitioner licensed under
19 ORS chapter 692 are not subject to cancellation or substantial revision.

20 (2) A person within the first applicable listed class among the following listed classes that is
21 available at the time of death, in the absence of actual notice of a contrary direction by the
22 decedent as described under subsection (1) of this section or actual notice of opposition by com-
23 pletion of a written instrument by a member of the same class or a member of a prior class, may
24 direct any lawful manner of disposition of a decedent's remains by completion of a written instru-
25 ment:

- 26 (a) The spouse of the decedent.
- 27 (b) A son or daughter of the decedent 18 years of age or older.
- 28 (c) Either parent of the decedent.
- 29 (d) A brother or sister of the decedent 18 years of age or older.
- 30 (e) A guardian of the decedent at the time of death.
- 31 (f) A person in the next degree of kindred to the decedent.
- 32 (g) The personal representative of the estate of the decedent.
- 33 (h) The person nominated as the personal representative of the decedent in the decedent's last
34 will.
- 35 (i) A public health officer.

36 (3)(a) The decedent or any person authorized in subsection (2) of this section to direct the
37 manner of disposition of the decedent's remains may delegate such authority to any person 18 years
38 of age or older.

39 (b) Delegation of the authority to direct the manner of disposition of remains must be made by
40 completion of:

- 41 (A) The written instrument described in subsection (8) of this section; or
- 42 (B) The form described in subsection (4) of this section.
- 43 (c) The person to whom the authority is delegated has the same authority under subsection (2)
44 of this section as the person delegating the authority.

45 (4)(a) A Record of Emergency Data, DD Form 93, or a successor form recognized by the Armed

1 Forces of the United States, as that term is defined in ORS 348.282, completed by a member of the
2 Armed Forces of the United States serves as a valid written instrument for purposes of subsection
3 (3) of this section.

4 (b) In accordance with United States Department of Defense Instruction 1300.18, a member of
5 the Armed Forces of the United States shall complete the form described in this subsection and shall
6 verify the accuracy of the form at least annually.

7 (c) The form described in this subsection, regardless of the date on which the form was signed,
8 supersedes any other written instrument that directs the disposition of the decedent's remains.

9 (5) Except as provided in subsection (4)(c) of this section, if a decedent or the decedent's
10 designee issues more than one authorization or direction for the disposal of the decedent's remains,
11 only the most recent authorization or direction is binding.

12 (6) A donation of anatomical gifts under ORS 97.951 to 97.982 takes priority over directions for
13 the disposition of a decedent's remains under this section only if the person making the donation is
14 of a priority under subsection (1) or (2) of this section the same as or higher than the priority of the
15 person directing the disposition of the remains.

16 (7) If the decedent directs a disposition under subsection (1) of this section and those financially
17 responsible for the disposition are without sufficient funds to pay for such disposition or the estate
18 of the decedent has insufficient funds to pay for the disposition, or if the direction is unlawful, the
19 direction is void and disposition shall be in accordance with the direction provided by the person
20 given priority in subsection (2) of this section and who agrees to be financially responsible.

21 (8) The signature of the individual delegating the authority to direct the manner of disposition
22 is required for the completion of the written instrument required in subsection (3)(b)(A) of this sec-
23 tion. The following form or a form substantially similar shall be used by all individuals:

(9) Subject to the provisions of ORS 97.951 to 97.982, if disposition of the remains of a decedent has not been directed and authorized under this section within 10 days after the date of the death of the decedent, a public health officer may direct and authorize disposition of the remains.

(10) Notwithstanding subsection (2) of this section, a person arrested for or charged with criminal homicide by reason of the death of the decedent may not direct the disposition of the decedent's remains. The disposition of the decedent's remains shall be made in accordance with the directions of an eligible person within the first applicable class established under subsection (2) of this section.

(11) Notwithstanding subsections (2) and (3) of this section, if the person who has the authority to direct the manner of disposition of cremated **or reduced** remains pursuant to subsection (1) or (2) of this section transfers any portion of the cremated **or reduced** remains to another person, the recipient of the cremated **or reduced** remains has the authority to direct the manner of disposition of the cremated **or reduced** remains in the recipient's possession.

97.130. (1) Any individual of sound mind who is 18 years of age or older, by completion of a written signed instrument or by preparing or prearranging with any funeral service practitioner licensed under ORS chapter 692, may direct any lawful manner of disposition of the individual's remains. Except as provided under subsection (7) of this section, disposition directions or disposition prearrangements that are prepaid or that are filed with a funeral service practitioner licensed under ORS chapter 692 are not subject to cancellation or substantial revision.

(2) A person within the first applicable listed class among the following listed classes that is available at the time of death, in the absence of actual notice of a contrary direction by the decedent as described under subsection (1) of this section or actual notice of opposition by completion of a written instrument by a member of the same class or a member of a prior class, may direct any lawful manner of disposition of a decedent's remains by completion of a written instrument:

- (a) The spouse of the decedent.
- (b) A son or daughter of the decedent 18 years of age or older.
- (c) Either parent of the decedent.
- (d) A brother or sister of the decedent 18 years of age or older.
- (e) A guardian of the decedent at the time of death.

(9) Subject to the provisions of ORS 97.951 to 97.982, if disposition of the remains of a decedent has not been directed and authorized under this section within 10 days after the date of the death of the decedent, a public health officer may direct and authorize disposition of the remains.

(10) Notwithstanding subsection (2) of this section, a person arrested for or charged with criminal homicide by reason of the death of the decedent may not direct the disposition of the decedent's remains. The disposition of the decedent's remains shall be made in accordance with the directions of an eligible person within the first applicable class established under subsection (2) of this section.

(11) Notwithstanding subsections (2) and (3) of this section, if the person who has the authority to direct the manner of disposition of cremated **or reduced** remains pursuant to subsection (1) or (2) of this section transfers any portion of the cremated **or reduced** remains to another person, the recipient of the cremated **or reduced** remains has the authority to direct the manner of disposition of the cremated **or reduced** remains in the recipient's possession.

97.145. No cemetery authority, crematory operator, **alternative disposition facility operator** or licensed funeral service practitioner interring [or], cremating **or reducing** remains pursuant to

1 a written instrument signed by the decedent or a person described in ORS 97.130 (2) shall be liable
 2 for any failure to conform to the priority of control of remains provided in ORS 97.130, except when
 3 it shall have received two or more conflicting written instruments prior to interment [*or*], cremation
 4 **or reduction** of said remains.

5 **SECTION 5.** ORS 97.150 is amended to read:

6 97.150. (1)(a) If the cemetery authority, crematory operator, **alternative disposition facility**
 7 **operator** or licensed funeral service practitioner has been authorized to cremate **or reduce** remains
 8 of a decedent pursuant to ORS 97.130, the authorization must also contain further instructions to
 9 the cemetery authority, crematory operator, **alternative disposition facility operator** or licensed
 10 funeral service practitioner as to the final disposition of the cremated **or reduced** remains.

11 (b) If the cremated **or reduced** remains are left in the possession of the cemetery authority,
 12 crematory operator, **alternative disposition facility operator** or licensed funeral service practi-
 13 tioner and no instructions for final disposition are given to the cemetery authority, crematory op-
 14 erator, **alternative disposition facility operator** or licensed funeral service practitioner within 180
 15 days after the date of cremation **or reduction**, the cemetery authority, crematory operator, **alter-**

 25 certified mail, return receipt requested, to the person who has the authority to direct disposition
 26 of the cremated **or reduced** remains at the address of the person in the records of the cemetery
 27 authority, crematory operator, **alternative disposition facility operator** or licensed funeral service
 28 practitioner.

29 (d) If the person who has the authority to direct the disposition of the cremated **or reduced**
 30 remains has not given instructions for the disposition of the cremated **or reduced** remains within
 31 30 days after the date of the notice, the cemetery authority, crematory operator, **alternative dis-**
 32 **position facility operator** or licensed funeral service practitioner may dispose of the cremated **or**
 33 **reduced** remains as is legally practicable.

34 (2) A cemetery authority, crematory operator, **alternative disposition facility operator** or li-
 35 censed funeral service practitioner is not liable in any civil or criminal proceeding relating to
 36 cremated **or reduced** remains that have been left in the possession of the cemetery authority,

6 (4) A cemetery authority is not liable in any civil or criminal proceeding relating to cremated
7 **or reduced** remains that have been scattered within the cemetery without the knowledge of the
8 cemetery authority. The cemetery authority may dispose of cremated **or reduced** remains that have
9 been scattered within the cemetery without the knowledge of the cemetery authority as is legally
10 practicable.

11 (5) If the cemetery authority, crematory operator, **alternative disposition facility operator** or
12 licensed funeral service practitioner has complied with this section, then the cemetery authority,

Lands held for the purposes described in this section shall be exempt from taxation as provided in ORS 307.150.

SECTION 13. ORS 97.665 is amended to read:

97.665. (1) A nonprofit corporation organized or existing solely for the purposes of either owning and operating a cemetery or cremating [*dead bodies*] **or reducing the bodies of deceased persons** and burying and caring for [*incinerate*] **cremated or reduced** remains may, by its bylaws, provide that a stated percentage of the money received from the sale of lots and burial space, cremation **or reduction** of bodies, donations, gifts or other sources of revenue shall constitute an irreducible fund. Any bylaw enacted for the creation of the irreducible fund cannot be amended to reduce the fund.

An officer of the corporation shall file with the Director of the Department of Consumer and Business Services on or before April 15 of each year a verified statement in duplicate containing the same information pertaining to the irreducible fund as provided in ORS 97.810 (4) regarding endowment care funds. The director may require the corporation to file, as often as the director considers it to be necessary, a detailed report of the conditions and assets of the irreducible fund.

(3) The interest or income arising from the irreducible fund provided for in this section or by any bylaws, or so much thereof as is necessary, shall be devoted exclusively to the preservation and embellishment of the grounds, buildings and property of the corporation and the lots and space in buildings or grounds sold to the members of the corporation, or to the payment of the interest or principal of the debts authorized by subsection (5) of this section for the purchase of land, erecting buildings, and improvements. Any surplus thereof not needed or used for such purposes shall be invested as provided in this section and shall become part of the irreducible fund.

(4) After paying for the land and the erection of the original buildings and improvements thereon, all the future receipts and income of the corporation subject to the provisions in this section relating to the creation of an irreducible fund, whether from the sale of lots and burial space, cremation **or reduction** of bodies, donations, gifts and other sources, shall be applied exclusively to laying out, preserving, protecting, embellishing and beautifying the cemetery, [*or*] the crematory **or the alternative disposition facility** and grounds thereof, and the avenues leading thereto, and to the erection of such buildings and improvements as may be necessary or convenient for cemetery [*or*], crematory **or reduction** purposes, and to pay the necessary expenses of the corporation.

(5) No debts shall be contracted by such corporation in anticipation of any future receipts, ex-

cept for originally purchasing the lands authorized to be purchased by it, laying out and embellishing the grounds and avenues, erecting buildings and vaults on such land, and improving them for the purposes of the corporation. The corporation may issue bonds or notes for debts so contracted and may secure them by way of mortgage upon any of its lands, buildings, property and improvements excepting lots or space conveyed to the members.

SECTION 14. ORS 97.670 is amended to read:

97.670. If in the board of directors' opinion, any portion of the lands of a nonprofit corporation organized and existing solely for the purposes of either owning or operating a cemetery or the cremation [*of dead bodies*] **or reduction of bodies of deceased persons** and the burial and care of [*incinerate*] **cremated or reduced** remains is unsuitable for burial purposes or other purposes of the corporation, the board of directors may sell such portion and apply the proceeds to the general purposes of such corporation in the same proportion and manner as provided by ORS 97.660 to 97.680.

SECTION 15. ORS 97.675 is amended to read:

97.675. Burial lots or space for burial of [*incinerate*] **cremated or reduced** remains in buildings or grounds sold by a nonprofit corporation organized and existing solely for the purposes of either owning and operating a cemetery or cremating [*dead bodies*] **or reducing the bodies of deceased persons** and burying and caring for [*incinerate*] **cremated or reduced** remains shall be for the sole purpose of interment or deposit and safekeeping of [*incinerate*] **cremated or reduced** remains. Such lots or space shall be exempt from execution, attachment or other lien or process, if used as intended by the purchaser thereof from such corporation, or the assigns or representatives of the purchaser, exclusively for burial purposes, and in no wise with a view to profit. Such lots or space shall be exempt from taxation as provided in ORS 307.150. The vendor of any gravestone, however, shall not be prevented from having and enforcing a lien thereon for all or part of its purchase price. If a suit is brought to enforce such a lien, the judgment therein is enforceable thereafter; and, for the purpose of enabling the lien to be had and enforced, the gravestone shall be deemed personal property and may be severed and removed, under execution and order of sale, from the lot where it is situated and may be sold in the same manner as any other personal property.

SECTION 16. ORS 97.680 is amended to read:

97.680. (1) As used in this section, "plan" means a document indicating the placement of lots or burial spaces, and of the niches or inurnment spaces in the buildings erected thereon, as established and authorized by the cemetery authority.

(2) A nonprofit corporation organized and existing solely for the purposes of owning and operating a cemetery or cremating [*dead bodies*] **or reducing the bodies of deceased persons** and burying and caring for [*incinerate*] **cremated or reduced** remains shall cause a plan of its land and grounds and of the lots laid out by it and of the niches or burial space in the buildings erected thereon to be made and recorded in the county in which such grounds and land are located, such lots or spaces to be numbered by regular consecutive numbers. SECTION 17. ORS 97.720 is amended to read:

97.720. (1) The person in charge of any premises on which interments [*or*], cremations **or reductions** are made shall keep a record of all remains interred or cremated **or reduced** on the premises under the person's charge, in each case stating the name of each deceased person, the date

1 of interment [*or*], cremation **or reduction**, and the name and address of the funeral service practi-
2 tioner. The interment records shall be open to inspection by survivors of the decedent during the
3 customary office hours of the cemetery authority.

20 a body part passes under ORS 97.969 may conduct any reasonable examination necessary to ensure
21 the medical suitability of the body or body part for its intended purpose.

22 (b) A transplant hospital may not deny a recipient from receiving an anatomical gift exclusively
23 on the basis that the recipient is a registry identification cardholder as defined in ORS 475B.791.

24 (5) Unless otherwise prohibited by law, an examination under subsection (3) or (4)(a) of this
25 section may include an examination of all medical and dental records of the donor or prospective
26 donor.

27 (6) Upon the death of a minor who was a donor or had signed a refusal, unless a procurement
28 organization knows the minor is emancipated, the procurement organization shall conduct a rea-
29 sonable search for the parents of the minor and provide the parents with an opportunity to revoke
30 or amend the anatomical gift or revoke the refusal.

31 (7) Upon referral by a hospital under subsection (1) of this section, a procurement organization

7 **SECTION 19.** ORS 692.010 is amended to read:

8 692.010. As used in this chapter:

9 (1) **“Alkaline hydrolysis” or “hydrolysis” means the technical process for reducing human**
10 **remains by placing the remains in a dissolution chamber that uses heat, pressure, water and**
11 **base chemical agents, in a licensed hydrolysis facility, to reduce human remains to bone**
12 **fragments and essential elements.**

13 [(1)] (2) “Board” means the State Mortuary and Cemetery Board.

14 [(2)] (3) “Cemetery” means any one, or a combination of more than one, of the following, in a
15 place used, or intended to be used, and dedicated, for cemetery purposes:

16 (a) A burial park, for earth interments;

17 (b) A mausoleum, for crypt interments;

18 (c) A columbarium, for permanent [*cinerary*] interments **of cremated or reduced remains;**

19 (d) A scattering garden or other designated area above or below ground where a person may
20 pay to establish a memorial of cremated **or reduced** remains; or

21 (e) A cenotaph, the primary purpose of which is to provide an area where a person may pay to
22 establish a memorial to honor a person whose remains may be interred elsewhere or whose remains
23 cannot be recovered.

24 [(3)] (4) “Exempt operating cemetery” means an operating cemetery that has 10 or fewer
25 interments annually.

26 [(4)] (5) “Final disposition” means the burial, interment, cremation, dissolution, **reduction** or
27 other disposition of human remains authorized by the board by rule.

28 [(5)] (6) “Holding room” means a room that is located in a licensed facility for the care, storage
29 or holding of dead human bodies prior to effecting disposition.

30 [(6)] (7) “Immediate disposition company” means any business licensed under this chapter, other
31 than a licensed funeral establishment, where a licensed funeral service practitioner operates the
32 business of immediate final disposition and where business records are kept.

33 (8) **“Natural organic reduction” means the contained, accelerated conversion of human**
34 **remains to soil.**

35 [(7)] (9) “Operating cemetery” means a cemetery that:

36 (a) Performs interments;

37 (b) Has fiduciary responsibility for endowment care, general care or special care funds; or

12 801.288. (1) "Funeral escort vehicle" means any two-wheel or three-wheel vehicle that is ac-
13 companying a funeral procession and is properly equipped under ORS 811.800.

14 (2) "Funeral lead vehicle" means any vehicle that is properly equipped under ORS 811.800 and
15 is used to lead and facilitate the movement of a funeral procession.

16 (3) "Funeral procession" means two or more vehicles, including any funeral lead vehicle or fu-
17 neral escort vehicle, accompanying the body or cremated **or reduced** remains of a deceased person.

18 **SECTION 32.** ORS 307.150 is amended to read:

19 307.150. (1) Notwithstanding ORS 307.022, upon compliance with ORS 307.162, the following
20 property is exempt from taxation:

21 (a) Burial grounds, tombs and rights of burial, and lands and buildings on the land, not exceed-
22 ing 30 acres, used for the sole purpose of a crematory [*and burial place to incinerate remains*] **or**
23 **alternative disposition facility, as defined in ORS 97.010, and for burial of incinerated or re-**
24 **duced remains.**

25 (b) Lands used or held exclusively for cemetery purposes, not exceeding 600 acres.

26 (c) Burial lots or space for burial of [*incinerate remains*] **incinerated or reduced remains** in
27 buildings or grounds used or held exclusively for burial purposes.

28 (d) Buildings on land described in paragraph (a) or (b) of this subsection that are used to store
29 machinery or equipment used exclusively for maintenance of burial grounds.

30 (e) Personal property used exclusively for cemetery, [*or*] crematory **or alternative disposition**
31 **facility** purposes.

32 (2) The statement required under ORS 307.162 shall be filed by the owner of the property de-
33 scribed in subsection (1) of this section.

34 (3) Any property exclusively occupied and used as a family burial ground is exempt from ad
35 valorem taxation.
