“DISPOSITION OF HUMAN BODIES

6 “**SECTION 1.** ORS 97.010 is amended to read:

7 “97.010. As used in ORS 97.010 to 97.040, 97.110 to 97.450, 97.510 to 97.730, 97.810 to 97.920,
8 97.923 to 97.949, 97.990 and 97.994:

9 “(1) **‘Alkaline hydrolysis’ or ‘hydrolysis’ means the technical process for reducing human**
10 **remains by placing the remains in a dissolution chamber that uses heat, pressure, water and**
11 **base chemical agents, in a licensed hydrolysis facility, to reduce human remains to bone**
12 **fragments and essential elements.**

13 “(2) **‘Alternative disposition facility’ means a structure containing equipment purposed**
14 **for reduction.**

15 “[1] (3) **‘Burial’** means the placement of human remains in a grave or lawn crypt.

16 “[2] (4) **‘Burial park’** means a tract of land for the burial of human remains, used, or intended
17 to be used, and dedicated for cemetery purposes.

18 “[3] (5) **‘Burial right’** means the right to use a grave, mausoleum, columbarium, ossuary or
19 scattering garden for the interment or other disposition of human remains.

20 “[4] (6) **‘Cemetery’** means a place:

21 “(a) Dedicated to and used, or intended to be used, for a permanent memorial or the permanent
22 interment of human remains; and

23 “(b) That may contain a mausoleum, crypt or vault interment, a columbarium, an ossuary, a
24 cenotaph, a scattering garden, any other structure or place used or intended to be used for the
25 interment or disposition of human remains or any combination of these structures or places.

26 “[5] (7) **‘Cemetery association’** means a corporation or association authorized by its articles
27 of incorporation to conduct the business of a cemetery, but does not include a corporation sole or
28 a charitable, eleemosynary association or corporation.

29 “[6] (8) **‘Cemetery authority’** means a person who owns or controls cemetery lands or property,
30 including but not limited to a cemetery corporation, association or corporation sole.

31 “[7] (9) **‘Cemetery business’** and **‘cemetery purpose’** are used interchangeably and mean any
32 business or purpose requisite or incident to, or necessary for establishing, maintaining, operating,
33 improving or conducting a cemetery, interring human remains, and the care, preservation and
34 embellishment of cemetery property.

35 “[8] (10) **‘Cemetery merchandise’** means personal property offered for sale or sold for use in

1 connection with the final disposition, memorialization or interment of human remains. ‘Cemetery
2 merchandise’ includes, but is not limited to, an outer burial container and a memorial.

3 “[9] (11) ‘Cemetery services’ means services provided by a cemetery authority for interment
4 or scattering, and installation of cemetery merchandise.

5 “[10] (12) ‘Cenotaph’ means a place, the primary purpose of which is to provide an area where
6 a person may pay to establish a memorial to honor a person whose remains may be interred else-
7 where or whose remains cannot be recovered.

8 “[11] (13) ‘Columbarium’ means a structure or room containing receptacles for permanent
9 inurnment of cremated **or reduced** remains in a place used, or intended to be used, and dedicated
10 for cemetery purposes.

11 “[12] (14) ‘Cremated remains’ means the remains of a cremated human body after completion
12 of the cremation process.

13 “[13] (15) ‘Cremation’ means the technical process, using direct flame and heat, that reduces
14 human remains to bone fragments.

15 “[14] (16) ‘Crematory’ means a structure containing a retort for the reduction of bodies of de-
16 ceased persons to cremated remains.

17 “[15] (17) ‘Crypt’ or ‘vault’ means a space in a mausoleum of sufficient size used, or intended
18 to be used, to entomb uncremated **or uncremated** human remains.

19 “[16] (18) ‘Directors’ or ‘governing body’ means the board of directors, board of trustees or
20 other governing body of a cemetery association.

21 “[17] (19) ‘Endowment care’ means the general care and maintenance of developed portions of
22 a cemetery and memorials erected thereon financed from the income of a trust fund.

23 “[18] (20) ‘Entombment’ means the placement of human remains in a crypt or vault.

24 “[19] (21) ‘Funeral merchandise’ means personal property offered for sale or sold for use in
25 connection with funeral services. ‘Funeral merchandise’ includes, but is not limited to, acknowledg-
26 ment cards, alternative containers, caskets, clothing, cremation containers, cremation interment
27 containers, flowers, memory folders, monuments, outer burial containers, prayer cards, register
28 books and urns.

29 “[20] (22) ‘Funeral services’ means services customarily provided by a funeral service practi-
30 tioner including, but not limited to, care and preparation of human remains for final disposition,
31 professional services relating to a funeral or an alternative to a funeral, transportation of human
32 remains, limousine services, use of facilities or equipment for viewing human remains, visitation,
33 memorial services or services that are used in connection with a funeral or alternative to a funeral,
34 coordinating or conducting funeral rites or ceremonies, and other services provided in connection
35 with a funeral, alternative to a funeral or final disposition of human remains.

36 “[21] (23) ‘Grave’ means a space of ground in a burial park used, or intended to be used, for
37 burial of the remains of one person.

38 “[22] (24) ‘Human remains’ or ‘remains’ means the body of a deceased person in any stage of
39 decomposition or after cremation **or reduction**.

40 “[23] (25) ‘Interment’ means the disposition of human remains by inurnment, entombment or
41 burial.

42 “[24] (26) ‘Inurnment’ means the placement of cremated **or reduced** remains in a receptacle
43 and the deposit of the receptacle in a niche.

44 “[25] (27) ‘Lot,’ ‘plot’ or ‘burial space’ means space in a cemetery owned by one or more indi-
45 viduals, an association or fraternal or other organization and used, or intended to be used, for the

1 permanent interment therein of the remains of one or more deceased persons. Such terms include
2 and apply with like effect to one, or more than one, adjoining grave, crypt, vault or niche.

3 “[26] (28) ‘Mausoleum’ means a structure substantially exposed above ground for the
4 entombment of human remains in crypts or vaults in a place used, or intended to be used, and ded-
5 icated for cemetery purposes.

6 “[27] (29) ‘Memorial’ means a product, other than a mausoleum or columbarium, used for
7 identifying an interment space or for commemoration of the life, deeds or career of a decedent in-
8 cluding, but not limited to, an ossuary, monument, marker, niche plate, urn garden plaque, crypt
9 plate, cenotaph, marker bench or vase.

10 “(30) **‘Natural organic reduction’ means the contained, accelerated conversion of human**
11 **remains to soil.**

12 “[28] (31) ‘Niche’ means a recess usually in a columbarium used, or intended to be used, for
13 the inurnment of the cremated **or reduced** remains of one or more persons.

14 “[29] (32) ‘Ossuary’ means a receptacle used for the communal placement of cremated **or re-**
15 **duced** remains without benefit of an urn or any other container in which cremated **or reduced** re-
16 mains may be commingled with other cremated **or reduced** remains and are nonrecoverable.

17 “[30] (33) ‘Plot owner’ or ‘owner’ means any person identified in the records of the cemetery
18 authority as owner of the burial rights to a burial plot, or who holds a certificate of ownership
19 conveyed from the cemetery authority of the burial rights in a particular lot, plot or space.

20 “(34) **‘Reduced remains’ means the remains of a human body after completion of re-**
21 **duction.**

22 “(35) **‘Reduction’ means alkaline hydrolysis, natural organic reduction and any other**
23 **method of final disposition of human remains authorized by the State Mortuary and Ceme-**
24 **tery Board.**

25 “[31] (36) ‘Scattering’ means the lawful dispersion of cremated **or reduced** remains that need
26 not be associated with an interment right or issuance of a deed, that may be recorded only as a
27 service that has taken place and may not be recorded on the permanent records of the cemetery
28 authority.

29 “[32] (37) ‘Scattering garden’ means a location set aside within a cemetery that is used for the
30 spreading or broadcasting of cremated **or reduced** remains that have been removed from their
31 container and can be mixed with or placed on top of the soil or ground cover or buried in an
32 underground receptacle on a commingled basis and that are nonrecoverable.

33 “[33] (38) ‘Special care’ means any care in excess of endowed care in accordance with the
34 specific directions of a donor of funds.

35 “**SECTION 2.** ORS 97.130 is amended to read:

36 “97.130. (1) Any individual of sound mind who is 18 years of age or older, by completion of a
37 written signed instrument or by preparing or prearranging with any funeral service practitioner li-
38 censed under ORS chapter 692, may direct any lawful manner of disposition of the individual’s re-
39 mains. Except as provided under subsection (7) of this section, disposition directions or disposition
40 prearrangements that are prepaid or that are filed with a funeral service practitioner licensed under
41 ORS chapter 692 are not subject to cancellation or substantial revision.

42 “(2) A person within the first applicable listed class among the following listed classes that is
43 available at the time of death, in the absence of actual notice of a contrary direction by the
44 decedent as described under subsection (1) of this section or actual notice of opposition by com-
45 pletion of a written instrument by a member of the same class or a member of a prior class, may

1 direct any lawful manner of disposition of a decedent's remains by completion of a written instru-
2 ment:

3 "(a) The spouse of the decedent.

4 "(b) A son or daughter of the decedent 18 years of age or older.

5 "(c) Either parent of the decedent.

6 "(d) A brother or sister of the decedent 18 years of age or older.

7 "(e) A guardian of the decedent at the time of death.

8 "(f) A person in the next degree of kindred to the decedent.

9 "(g) The personal representative of the estate of the decedent.

10 "(h) The person nominated as the personal representative of the decedent in the decedent's last
11 will.

12 "(i) A public health officer.

13 "(3)(a) The decedent or any person authorized in subsection (2) of this section to direct the
14 manner of disposition of the decedent's remains may delegate such authority to any person 18 years
15 of age or older.

16 "(b) Delegation of the authority to direct the manner of disposition of remains must be made by
17 completion of:

18 "(A) The written instrument described in subsection (8) of this section; or

19 "(B) The form described in subsection (4) of this section.

20 "(c) The person to whom the authority is delegated has the same authority under subsection (2)
21 of this section as the person delegating the authority.

22 "(4)(a) A Record of Emergency Data, DD Form 93, or a successor form recognized by the Armed
23 Forces of the United States, as that term is defined in ORS 348.282, completed by a member of the
24 Armed Forces of the United States serves as a valid written instrument for purposes of subsection
25 (3) of this section.

26 "(b) In accordance with United States Department of Defense Instruction 1300.18, a member of
27 the Armed Forces of the United States shall complete the form described in this subsection and shall
28 verify the accuracy of the form at least annually.

29 "(c) The form described in this subsection, regardless of the date on which the form was signed,
30 supersedes any other written instrument that directs the disposition of the decedent's remains.

31 "(5) Except as provided in subsection (4)(c) of this section, if a decedent or the decedent's
32 designee issues more than one authorization or direction for the disposal of the decedent's remains,
33 only the most recent authorization or direction is binding.

34 "(6) A donation of anatomical gifts under ORS 97.951 to 97.982 takes priority over directions for
35 the disposition of a decedent's remains under this section only if the person making the donation is
36 of a priority under subsection (1) or (2) of this section the same as or higher than the priority of the
37 person directing the disposition of the remains.

38 "(7) If the decedent directs a disposition under subsection (1) of this section and those finan-
39 cially responsible for the disposition are without sufficient funds to pay for such disposition or the
40 estate of the decedent has insufficient funds to pay for the disposition, or if the direction is unlawful,
41 the direction is void and disposition shall be in accordance with the direction provided by the person
42 given priority in subsection (2) of this section and who agrees to be financially responsible.

43 "(8) The signature of the individual delegating the authority to direct the manner of disposition
44 is required for the completion of the written instrument required in subsection (3)(b)(A) of this sec-
45 tion. The following form or a form substantially similar shall be used by all individuals:

“(9) Subject to the provisions of ORS 97.951 to 97.982, if disposition of the remains of a decedent has not been directed and authorized under this section within 10 days after the date of the death of the decedent, a public health officer may direct and authorize disposition of the remains.

“(10) Notwithstanding subsection (2) of this section, a person arrested for or charged with criminal homicide by reason of the death of the decedent may not direct the disposition of the decedent’s remains. The disposition of the decedent’s remains shall be made in accordance with the directions of an eligible person within the first applicable class established under subsection (2) of this section.

1 “(11) Notwithstanding subsections (2) and (3) of this section, if the person who has the authority
2 to direct the manner of disposition of cremated **or reduced** remains pursuant to subsection (1) or
3 (2) of this section transfers any portion of the cremated **or reduced** remains to another person, the
4 recipient of the cremated **or reduced** remains has the authority to direct the manner of disposition
5 of the cremated **or reduced** remains in the recipient’s possession.

6 “**SECTION 3.** ORS 97.130, as amended by section 12a, chapter 384, Oregon Laws 2019, is
7 amended to read:

8 “97.130. (1) Any individual of sound mind who is 18 years of age or older, by completion of a
9 written signed instrument or by preparing or prearranging with any funeral service practitioner li-
10 censed under ORS chapter 692, may direct any lawful manner of disposition of the individual’s re-
11 mains. Except as provided under subsection (7) of this section, disposition directions or disposition
12 prearrangements that are prepaid or that are filed with a funeral service practitioner licensed under
13 ORS chapter 692 are not subject to cancellation or substantial revision.

14 “(2) A person within the first applicable listed class among the following listed classes that is
15 available at the time of death, in the absence of actual notice of a contrary direction by the
16 decedent as described under subsection (1) of this section or actual notice of opposition by com-
17 pletion of a written instrument by a member of the same class or a member of a prior class, may
18 direct any lawful manner of disposition of a decedent’s remains by completion of a written instru-
19 ment:

20 “(a) The spouse of the decedent.

21 “(b) A son or daughter of the decedent 18 years of age or older.

22 “(c) Either parent of the decedent.

39 “(4)(a) A Record of Emergency Data, DD Form 93, or a successor form recognized by the Armed
40 Forces of the United States, as that term is defined in ORS 366.931, completed by a member of the
41 Armed Forces of the United States serves as a valid written instrument for purposes of subsection
42 (3) of this section.

43 “(b) In accordance with United States Department of Defense Instruction 1300.18, a member of
44 the Armed Forces of the United States shall complete the form described in this subsection and shall
45 verify the accuracy of the form at least annually.

1 “(c) The form described in this subsection, regardless of the date on which the form was signed,
2 supersedes any other written instrument that directs the disposition of the decedent’s remains.

3 “(5) Except as provided in subsection (4)(c) of this section, if a decedent or the decedent’s
4 designee issues more than one authorization or direction for the disposal of the decedent’s remains,
5 only the most recent authorization or direction is binding.

6 “(6) A donation of anatomical gifts under ORS 97.951 to 97.982 takes priority over directions for
7 the disposition of a decedent’s remains under this section only if the person making the donation is
8 of a priority under subsection (1) or (2) of this section the same as or higher than the priority of the
9 person directing the disposition of the remains.

10 “(7) If the decedent directs a disposition under subsection (1) of this section and those finan-
11 cially responsible for the disposition are without sufficient funds to pay for such disposition or the
12 estate of the decedent has insufficient funds to pay for the disposition, or if the direction is unlawful,
13 the direction is void and disposition shall be in accordance with the direction provided by the person
14 given priority in subsection (2) of this section and who agrees to be financially responsible.

15 “(8) The signature of the individual delegating the authority to direct the manner of disposition
16 is required for the completion of the written instrument required in subsection (3)(b)(A) of this sec-
17 tion. The following form or a form substantially similar shall be used by all individuals:

10 “(9) Subject to the provisions of ORS 97.951 to 97.982, if disposition of the remains of a decedent
11 has not been directed and authorized under this section within 10 days after the date of the death
12 of the decedent, a public health officer may direct and authorize disposition of the remains.

13 “(10) Notwithstanding subsection (2) of this section, a person arrested for or charged with
14 criminal homicide by reason of the death of the decedent may not direct the disposition of the
15 decedent’s remains. The disposition of the decedent’s remains shall be made in accordance with the
16 directions of an eligible person within the first applicable class established under subsection (2) of
17 this section.

18 “(11) Notwithstanding subsections (2) and (3) of this section, if the person who has the authority
19 to direct the manner of disposition of cremated **or reduced** remains pursuant to subsection (1) or
20 (2) of this section transfers any portion of the cremated **or reduced** remains to another person, the
21 recipient of the cremated **or reduced** remains has the authority to direct the manner of disposition
22 of the cremated **or reduced** remains in the recipient’s possession.

23 “**SECTION 4.** ORS 97.145 is amended to read:

24 “97.145. No cemetery authority, crematory operator, **alternative disposition facility operator**
25 or licensed funeral service practitioner interring [*or*], cremating **or reducing** remains pursuant to
26 a written instrument signed by the decedent or a person described in ORS 97.130 (2) shall be liable
27 for any failure to conform to the priority of control of remains provided in ORS 97.130, except when
28 it shall have received two or more conflicting written instruments prior to interment [*or*], cremation
29 **or reduction** of said remains.

30 “**SECTION 5.** ORS 97.150 is amended to read:

31 “97.150. (1)(a) If the cemetery authority, crematory operator, **alternative disposition facility**
32 **operator** or licensed funeral service practitioner has been authorized to cremate **or reduce** remains
33 of a decedent pursuant to ORS 97.130, the authorization must also contain further instructions to
34 the cemetery authority, crematory operator, **alternative disposition facility operator** or licensed
35 funeral service practitioner as to the final disposition of the cremated **or reduced** remains.

36 “(b) If the cremated **or reduced** remains are left in the possession of the cemetery authority,
37 crematory operator, **alternative disposition facility operator** or licensed funeral service practi-
38 tioner and no instructions for final disposition are given to the cemetery authority, crematory op-
39 erator, **alternative disposition facility operator** or licensed funeral service practitioner within 180
40 days after the date of cremation **or reduction**, the cemetery authority, crematory operator, **alter-**
41 **native disposition facility operator** or licensed funeral service practitioner shall make a reason-
42 able effort to notify the person who has the authority to direct disposition of the cremated **or**
43 **reduced** remains under ORS 97.130 (2). The notice must state that the cemetery authority,
44 crematory operator, **alternative disposition facility operator** or licensed funeral service practi-
45 tioner intends to dispose of the cremated **or reduced** remains unless the person who has the au-

1 thority to direct disposition of the cremated **or reduced** remains gives instructions to the contrary
2 to the cemetery authority, crematory operator, **alternative disposition facility operator** or li-
3 censed funeral service practitioner within 30 days after the date of the notice.

4 “(c) Reasonable effort to notify includes, but is not limited to, notice, delivered personally or
5 by certified mail, return receipt requested, to the person who has the authority to direct disposition
6 of the cremated **or reduced** remains at the address of the person in the records of the cemetery
7 authority, crematory operator, **alternative disposition facility operator** or licensed funeral service
8 practitioner.

9 “(d) If the person who has the authority to direct the disposition of the cremated **or reduced**
10 remains has not given instructions for the disposition of the cremated **or reduced** remains within
11 30 days after the date of the notice, the cemetery authority, crematory operator, **alternative dis-
12 position facility operator** or licensed funeral service practitioner may dispose of the cremated **or
13 reduced** remains as is legally practicable.

14 “(2) A cemetery authority, crematory operator, **alternative disposition facility operator** or li-
15 censed funeral service practitioner is not liable in any civil or criminal proceeding relating to
16 cremated **or reduced** remains that have been left in the possession of the cemetery authority,
17 crematory operator, **alternative disposition facility operator** or licensed funeral service practi-
18 tioner for a period of 180 days or more unless:

19 “(a) The cemetery authority, crematory operator, **alternative disposition facility operator** or
20 licensed funeral service practitioner has failed to make a reasonable effort to notify the person who
21 has the authority to direct disposition of the cremated **or reduced** remains as described in sub-
22 section (1) of this section;

23 “(b) A written contract has been entered into with the cemetery authority, crematory
24 operator, **alternative disposition facility operator** or licensed funeral service practitioner for care
25 of the cremated **or reduced** remains; or

26 “(c) Permanent interment has been made.

27 “(3) A cemetery authority is not liable in any civil or criminal proceeding relating to cremated
28 **or reduced** remains that have been interred, scattered, placed in an ossuary or disposed of in any
29 other manner within the cemetery if the person who physically possesses the cremated **or reduced**
30 remains consents to the disposition.

31 “(4) A cemetery authority is not liable in any civil or criminal proceeding relating to cremated
32 **or reduced** remains that have been scattered within the cemetery without the knowledge of the
33 cemetery authority. The cemetery authority may dispose of cremated **or reduced** remains that have
34 been scattered within the cemetery without the knowledge of the cemetery authority as is legally
35 practicable.

36 “(5) If the cemetery authority, crematory operator, **alternative disposition facility operator**
37 or licensed funeral service practitioner has complied with this section, then the cemetery authority,
38 crematory operator, **alternative disposition facility operator** or licensed funeral service practi-

35 “**SECTION 13.** ORS 97.665 is amended to read:

29 contracted and may secure them by way of mortgage upon any of its lands, buildings, property and

11 burial spaces, and of the niches or inurnment spaces in the buildings erected thereon, as established

3 “(b) A transplant hospital may not deny a recipient from receiving an anatomical gift exclusively
4 on the basis that the recipient is a registry identification cardholder as defined in ORS 475B.791.

5 “(5) Unless otherwise prohibited by law, an examination under subsection (3) or (4)(a) of this
6 section may include an examination of all medical and dental records of the donor or prospective
7 donor.

8 “(6) Upon the death of a minor who was a donor or had signed a refusal, unless a procurement
9 organization knows the minor is emancipated, the procurement organization shall conduct a rea-
10 sonable search for the parents of the minor and provide the parents with an opportunity to revoke

43 “(b) A mausoleum, for crypt interments;

44 “(c) A columbarium, for permanent [*cinery*] interments **of cremated or reduced remains;**

45 “(d) A scattering garden or other designated area above or below ground where a person may

1 pay to establish a memorial of cremated **or reduced** remains; or

2 “(e) A cenotaph, the primary purpose of which is to provide an area where a person may pay
3 to establish a memorial to honor a person whose remains may be interred elsewhere or whose re-
4 mains cannot be recovered.

5 “[3] (4) ‘Exempt operating cemetery’ means an operating cemetery that has 10 or fewer
6 interments annually.

7 “[4] (5) ‘Final disposition’ means the burial, interment, cremation, dissolution, **reduction** or
8 other disposition of human remains authorized by the board by rule.

9 “[5] (6) ‘Holding room’ means a room that is located in a licensed facility for the care, storage

28 vidual is licensed as a funeral service practitioner under ORS 692.045. Regardless of any title used
29 by the individual, an individual practices as a funeral service practitioner if the individual is en-
30 gaged directly or indirectly in offering funeral services for payment or supervising or otherwise
31 controlling the transportation, care, preparation, processing and handling of dead human bodies be-
32 fore the bodies undergo final disposition, or before the bodies are transported out of the State of
33 Oregon.

34 “(2) An individual may not practice as an embalmer unless the individual is licensed as an
35 embalmer under ORS 692.105. Regardless of any title used by the individual, an individual practices
36 as an embalmer if the individual is engaged or purports to be engaged in either of the following:

37 “(a) The practice of disinfecting or preserving from decay dead human bodies.

38 “(b) Preparing human bodies dead of contagious or infectious disease for transportation by
39 railroad, express company or common carrier.

40 “(3) An individual may not practice as a death care consultant unless the individual is licensed
41 as a death care consultant under ORS 692.143. Regardless of any title used by the individual, an
42 individual practices as a death care consultant if the individual offers, for payment, consultations
43 directly relating to the performance of funeral or final disposition services.

44 “(4) A person may not operate a funeral establishment unless the establishment meets the re-
45 quirements under this subsection. A place is a funeral establishment if the place is customarily used

1 for the care, preparation or viewing of dead human bodies before the bodies undergo final disposi-
2 tion, or before the bodies are transported out of the State of Oregon. A funeral establishment must:

3 “(a) Be licensed by the State Mortuary and Cemetery Board under ORS 692.146;

4 “(b) Be operated by a funeral service practitioner;

5 “(c) Have on the premises embalming facilities or holding room facilities meeting requirements
6 established by the board; and

7 “(d) Have access to hospital or mortuary refrigeration.

8 “(5) A person may not operate an immediate disposition company unless the immediate disposi-
9 tion company meets the requirements under this subsection. An immediate disposition company

11 “(a) Be licensed at a fixed location under ORS 692.146; and

13 “(31) **‘Reduction’ means an authorized process for reducing human remains. Authorized**

24 “(a) The collection, registration, preservation, amendment, certification and verification of, and
25 the maintenance of the security and integrity of, vital records;

26 “(b) The collection of reports required by this chapter; and

27 “(c) Activities related to the activities described in paragraphs (a) and (b) of this subsection,
28 including the tabulation, analysis, dissemination and publication of vital statistics and training in
29 the use of health data.

30 “[33] (36) ‘Verification’ means confirmation of the information on a vital record based on the
31 facts contained in a report.

32 “[34] (37) ‘Vital record’ means a report of a live birth, death, fetal death, marriage, declaration
33 of domestic partnership, dissolution of marriage or domestic partnership and related data that have
34 been accepted for registration and incorporated into the official records of the Center for Health
35 Statistics.

36 “[35] (38) ‘Vital statistics’ means the aggregated data derived from records and reports of live
37 birth, death, fetal death, induced termination of pregnancy, marriage, declaration of domestic part-
38 nership, dissolution of marriage, dissolution of domestic partnership and supporting documentation
39 and related reports.

40 “**SECTION 31.** ORS 801.288 is amended to read:

41 “801.288. (1) ‘Funeral escort vehicle’ means any two-wheel or three-wheel vehicle that is ac-
42 companying a funeral procession and is properly equipped under ORS 811.800.

43 “(2) ‘Funeral lead vehicle’ means any vehicle that is properly equipped under ORS 811.800 and
44 is used to lead and facilitate the movement of a funeral procession.

45 “(3) ‘Funeral procession’ means two or more vehicles, including any funeral lead vehicle or fu-

1 neral escort vehicle, accompanying the body or cremated **or reduced** remains of a deceased person.

2 “**SECTION 32.** ORS 307.150 is amended to read:

3 “307.150. (1) Notwithstanding ORS 307.022, upon compliance with ORS 307.162, the following
4 property is exempt from taxation:

5 “(a) Burial grounds, tombs and rights of burial, and lands and buildings on the land, not ex-
6 ceeding 30 acres, used for the sole purpose of a crematory [*and burial place to incinerate remains*]
7 **or alternative disposition facility, as defined in ORS 97.010, and for burial of incinerated or**
8 **reduced remains.**

9 “(b) Lands used or held exclusively for cemetery purposes, not exceeding 600 acres.

10 “(c) Burial lots or space for burial of [*incinerate remains*] **incinerated or reduced remains** in
11 buildings or grounds used or held exclusively for burial purposes.

12 “(d) Buildings on land described in paragraph (a) or (b) of this subsection that are used to store
13 machinery or equipment used exclusively for maintenance of burial grounds.

14 “(e) Personal property used exclusively for cemetery, [*or*] crematory **or alternative disposition**
15 **facility** purposes.

16 “(2) The statement required under ORS 307.162 shall be filed by the owner of the property de-
17 scribed in subsection (1) of this section.

18 “(3) Any property exclusively occupied and used as a family burial ground is exempt from ad
19 valorem taxation.

20 “**SECTION 33.** (1) **The amendments to ORS 97.010, 97.130, 97.145, 97.150, 97.153, 97.170,**
21 **97.200, 97.220, 97.510, 97.660, 97.665, 97.670, 97.675, 97.680, 97.720, 97.972, 146.121, 147.005, 226.410,**
22 **307.150, 409.742, 413.195, 432.005, 692.010, 692.025, 692.040, 692.148, 692.275, 692.405 and 801.288**
23 **by sections 1 to 32 of this 2021 Act become operative on July 1, 2022.**

24 “(2) **The State Mortuary and Cemetery Board may take any action before the operative**
25 **date specified in subsection (1) of this section that is necessary for the board to exercise, on**
26 **and after the operative date specified in subsection (1) of this section, all of the duties,**
27 **functions and powers conferred on the board by the amendments to ORS 692.010, 692.025,**
28 **692.040, 692.148, 692.275 and 692.405 by sections 19 to 24 of this 2021 Act.**

29 “**SECTION 34.** **The unit captions used in this 2021 Act are provided only for the conven-**
30 **ience of the reader and do not become part of the statutory law of this state or express any**
31 **legislative intent in the enactment of this 2021 Act.”.**
