

House Bill 2865

Sponsored by Representative EVANS (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires statement of economic interest to be filed by all members of board of directors or governing body of nonprofit that has either received or submitted testimony to Legislative Assembly requesting \$1 million or more in state capital construction funding over previous five calendar years.

Requires statement of economic interest to be filed by all members of board of directors or governing body of any business that has received \$1 million or more in state capital construction funding over previous five calendar years.

A BILL FOR AN ACT

2 Relating to statements of economic interest; creating new provisions; and amending ORS 244.050.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 244.050 is amended to read:

5 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon
6 Government Ethics Commission a verified statement of economic interest as required under this
7 chapter:

8 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the
9 Bureau of Labor and Industries, district attorneys and members of the Legislative Assembly.

10 (b) Any judicial officer, including justices of the peace and municipal judges, except any pro tem
11 judicial officer who does not otherwise serve as a judicial officer.

12 (c) Any candidate for a public office designated in paragraph (a) or (b) of this subsection.

13 (d) The Deputy Attorney General.

14 (e) The Deputy Secretary of State.

15 (f) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the
16 Legislative Policy and Research Director, the Secretary of the Senate, the Chief Clerk of the House
17 of Representatives and the Legislative Equity Officer.

18 (g) The president and vice presidents, or their administrative equivalents, in each public uni-
19 versity listed in ORS 352.002.

20 (h) The following state officers:

21 (A) Adjutant General.

22 (B) Director of Agriculture.

23 (C) Manager of State Accident Insurance Fund Corporation.

24 (D) Water Resources Director.

25 (E) Director of Department of Environmental Quality.

26 (F) Director of Oregon Department of Administrative Services.

 4 **in state capital construction funding over the previous five calendar years.**

5 **(x) Every member of the board of directors or governing body of any business that has**
 6 **received \$1 million or more in state capital construction funding over the previous five cal-**
 7 **endar years.**

8 (2) By April 15 next after the date an appointment takes effect, every appointed public official
 9 on a board or commission listed in subsection (1) of this section shall file with the Oregon Govern-
 10 ment Ethics Commission a statement of economic interest as required under ORS 244.060, 244.070
 11 and 244.090.

12 (3) By April 15 next after the filing deadline for the primary election, each candidate described
 13 in subsection (1) of this section shall file with the commission a statement of economic interest as
 14 required under ORS 244.060, 244.070 and 244.090.

15 (4) Not later than the 40th day before the date of the statewide general election, each candidate
 16 described in subsection (1) of this section who will appear on the statewide general election ballot
 17 and who was not required to file a statement of economic interest under subsections (1) to (3) of this
 18 section shall file with the commission a statement of economic interest as required under ORS
 19 244.060, 244.070 and 244.090.

20 (5) Subsections (1) to (3) of this section apply only to persons who are incumbent, elected or
 21 appointed public officials as of April 15 and to persons who are candidates on April 15.

22 (6) If a statement required to be filed under this section has not been received by the commis-
 23 sion within five days after the date the statement is due, the commission shall notify the public of-
 24 ficial or candidate and give the public official or candidate not less than 15 days to comply with the
 25 requirements of this section. If the public official or candidate fails to comply by the date set by the
 26 commission, the commission may impose a civil penalty as provided in ORS 244.350.

27 **SECTION 2. The amendments to ORS 244.050 by section 1 of this 2021 Act apply to state**
 28 **capital construction funding that is received or requested on or after the effective date of**
 29 **this 2021 Act.**
